## MINUTES | CITY OF PIKEVILLE

At a regular adjourned meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 29th day of June, 1934, the following were present:

Mayor, K. J. Day, and Councilmen, Clyde Childers, A. S. Johnson, Rush Sword, G. C. Call and H. E. Syck.

Councilman, Arthur Fields, was absent.

The city clerk presented and read to the Council the following, which was filed with him June 27th, 1934:

"ACCEPTANCE.

TO THE COUNCIL OF THE CITY OF PIKEVILLE, PIKE COUNTY, KENTUCKY:

Whereas, on or about the 1st day of May, 1934, the Common

Council of the City of Pikeville, Pike County, Kentucky, passed an

ordinance granting to:

KENTUCKY AND WEST VIRGINIA POWER COMPANY, Inc., its successors and assigns, the right, privilege, franchise and authority to construct, maintain and operate in, above, under, across and along the streets, thoroughfares, alleys, bridges and public places of the City of Pikeville, lines for the distribution of electric energy,

Whereas, the undersigned, Kentucky and West Virginia Power Company, Inc. is willing to accept said ordinance in accordance with the terms and conditions therein set forth,

NOW, THEREFORE,

The said Kentucky and West Virginia Power Company, Inc.
hereby assents to and accepts the terms and conditions of said ordinance and agrees to be bound and abide by said terms and conditions in said ordinance set forth.

There is now pending in the Circuit Court for Pike County a taxpayers' suit attacking the validity of this franchise. It must be understood that the undersigned, Kentucky and West Virginia Power Company, Inc., will expect to have the purchase price of said franchise returned if it should be adjudged that said franchise as granted

Upon motion of Clyde Childers, duly seconded by A. S. Johnson and carried J. W. Call is granted permit to erect a marquette or shed over side walk in front of his new building on Second Street, provided same does not conflict with, and is done in accordance with the terms of city ordinances, rules and regulations.

Mrs. Mintaha Saad presented bond for \$1000.00 with Fidelity & Deposit Company of Baltimore, Maryland, as surety, for whiskey license; and upon motion made, duly seconded and carried said bond was accepted and the city clerk directed to issue license accordingly.

J. D. Hatfield presented application for whiskey license, same to be sold in unbroken packages, with receipt of City Treasurer for \$200.00. Upon motion made, duly seconded and carried, the said application is accepted and the city clerk is directed to issue said license when surety bond in the sum of \$1000.00 is received.

Clyde Childers in troduced an ordinance entitled "AN ORDINANCE imposing a license tax on all persons, firms or corporations operating opera houses, theaters and moving picture theaters in the City of Pikeville, Kentucky, and fixing a penalty for violation of this ordinance", and moved that said ordinance be passed and adopted. A. S. Johnson seconded said motion. Upon roll call the vote was as follows:

The mayor declared said motion carried and said ordinance duly passed and adopted.

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 3rd day of July, 1934, the following were present:

Mayor, K. J. Day, and Councilmen, A. S. Johnson, G. C. Call, H. E. Syck and Clyde Childers.

Councilmen, Rush Sword and Arthur Fields, were absent.

George H. Thomas appeared before the council and asked that parking be permitted in front of his residence on Third Street, on parkway or that part of street between side walk and curb, and said matter was passed for further consideration.

T. M. Watkins appeared before the council, and explained installation of signal lights for the police department, its cost &c., and said matter was passed for further consideration.

Julien Auxier appeared and asked for permit to erect one story frame building on Poplar Street. Rush Sword moved that said permit be granted, not to conflict in anywise with any city ordinance, rule or regulation. A. S. Johnson seconded said motion, which carried.

With the mayor, to investigate the status of the suit of certain citizens against Kentucky and West Virginia Power Company and the City of Pikeville, and report to the council whether or not the city shall employ additional counsel to represent it, and also employ additional counsel, if they deem necessary. A. S. Johnson seconded said motion, which carried.

The Mayor appointed Rush Sword and H. E. Syck, together with himself, as committee to investigate status of the suit of certain citizens against Kentucky and West Virginia Power Company and City of Pikeville, and report its findings to the council at its next regular meeting.

W. E. Turner appeared before the council and asked that he be exonorated from the payment of poll taxes to the City of Pikeville, for reason that he is 69 years of age. H. E. Syck moved that W. E. Turner be exonorated from the payment of poll taxes to the City of Pikeville. Clyde Childers seconded said motion, which carried.
