MINUTES { CITY OF PIKEVILLE

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 17th day of July, 1934, the following were present:

A. S. Johnson, G. C. Call, Arthur Fields, and Clyde Childers.

The following councilmen were absent: Rush Sword and H. E. Syck.

0. 0. Scott appeared before the council and asked that the York barn on lower Second Street be removed. Arthur Fields moved that proper steps be taken in regard to removal of said barn. A. S. Johnson seconded said motion, which carried.

Councilman, H. E. Syck, is now present.

J. G. Harrison appeared before the council and asked that a certain street light be moved a distance of one pole on Elm Street, that is, transferred from one pole to another pole, and said matter is referred to the Street Committee.

J. A. Taylor appeared before the council and stated, he had garnisheed Alfred Mullins in police court, garnishment having been summoned upon the city, and that he had heard nothing from same; and the matter of Alfred Mullins bill is referred to councilman, H. E. Syck, who shall report his finding to the council at its next regular meeting.

It appearing that Kentucky and West Virginia Power Company heretofore deposited with the city certified check for \$50.00 for performance of its street lighting confract, upon motion made, duly seconded and carried said check is ordered returned to the Kentucky and West Virginia Power Company.

Upon motion made, duly seconded and carried the General Service Garage is granted a permit to remodel building and driveway on corner of Second and Huffman Streets, same to be done under the supervision of the city engineer and in accordance with the terms of all city ordinances, rules and regulations.

Upon motion made, duly seconded and carried James Hatcher is granted permit to erect two story building on his lot on Main Street, east side thereof, same to conform in all respects to the terms of all city ordinances, rules and regulations.

Application of Ashland Refining Company for permit to build and operate gasoline filling station at northeast corner of Second Street and Scott Avenue in City of Pikeville, and on property known as Phoebe Davis King lot, was filed and presented to the council.

Arthur Fields moved that the above permit be granted, same to conform in all respects to the terms of all city ordinances, rules and regulations. A. S. Johnson seconded said motion, which carried.

ORDERED THAT:

Kentucky Wholesale Company be, and it is hereby allowed the sum of \$19.73 for amount paid W. S. Darley & Company for sulphuric acid and soda shipped C? O. D. for fire department, payable out of Fire Department Budget Fund.

ORDERED THAT:

J. M. Hatcher, City Clerk, be, and he is hereby allowed the sum of \$52.11 for making street paving assessments and sending out notices for the year 1934, payable out of Officers' Salary Budget Fund. Said bill was \$57.90, but only \$52.11, and to the disallowance of balance of \$5.79 said Hatcher excepts, and accepts said \$52.11 as credit only.

Applications of W. M. Gilbert and J. D. Sword for position as superintendent to build city jail and fire station were presented and read, and said matter was referred to the Building Committee.

G. C. Call moved that the city engineer be directed to locate South Hellier Street from Division Street to Elm Street. Arthur Fields seconded said motion, which carried.

Clyde Childers moved that G. C. Honaker be compelled to comply with city ordinances with reference to building which he erected at rear of Walters & Walters Building on Second Street; and that the city engineer be directed to ascertain if city ordinances have been violated in the building of same: and, if so, the city attorney is authorized and directed to institute suit for the removal of same. G. C. Call seconded said motion, which carried.

Upon motion made, duly seconded and carried the city attorney is directed to prepare ordinance segregating taxis on end of Division Street between First National Bank Building and the court house, and present same to the council at its next regular meeting.

A. S. Johnson moved that the City treasurer be allowed vouchers for the following amounts for rights of way on Cline Street, which have heretofore been paid by him by check: Jake P. Cline, \$300.00; W. K. Steele, \$150.00; W. P. Call, \$200.00; Dr. R. S. Johnson, \$200.00. Clyde Childers seconded said motion, which carried.

New York Restaurant filed application to sell whiskey by the package, accompanied by city treasurer's receipt in the sum of \$200.00 and bond in the sum of \$1000.00 with The Fidelity and Casualty Company of New York as surety. Upon motion made, dury seconded and carried said application and bond were accepted and said licenses ordered issued.

T. H. Fife appeared before the council and asked that parking be stopped in front of his boarding house on Main Street except for guests only, and the police are directed to mark "No Parking" places in front of his said boarding house.

It appearing that the Cincinnati Bargain Store did not enter business until May 1, 1933, not having any property in the city prior to the above date, and the city assessor erroneously assessed the said Cincinnati Bargain Store for city taxes for the year 1933; it is, therefore, ordered that the said Cincinnati Bargain Store be, and it is hereby exonorated from the payment of taxes on said assessment for the year 1933, and the said store having paid taxes for said year in the sum of \$5.57, same are ordered refunded to the said Cincinnati Bargain Store. Therefore,

ORDERED THAT:

The Cincinnati Bargain Store be, and it is hereby allowed the sum of \$5.57 for refund on 1933 taxes, the store not being in operation April 1, 1933, payable out of General Expenditure Budget Fund.
