At a regular adjourned meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the City Hall in the City of Pikeville, Kentucky, on the 24th day of July, 1934, the following were present:

Councilmen, Rush Sword, Arthur Fields and A. S. Johnson, were absent.

Mrs. T. H. Deskins, doing business in name of Gray Eagle Restaurant, filed application for beer licenses, with T. H. Deskins and T. M. Stratton as sureties. Upon motion made, duly seconded and carried said application and bond were accepted and said licenses ordered issued.

A. C. Huffman filed application for beer license with R. T. Huffman as surety. Upon motion made, duly seconded and carried said application and bond were accepted and said license ordered issued.

New York Restaurant filed application to sell whiskey by the package, accompanied by city treasurer's receipt in the sum of \$200.00 and bond in the sum of \$1000.00 with The Fidelity and Casualty Company of New York as surety. Upon motion made, duly seconded and carried said application and bond were accepted and said licenses ordered issued.

T. H. Fife appeared before the council and asked that parking be stopped in front of his boarding house on Main Street except for guests only, and the police are directed to mark "No Parking" places in front of his said boarding house.

It appearing that the Cincinnati Bargain Store did not enter business until May 1, 1933, not having any property in the city prior to the above date, and the city assessor erroneously assessed the said Cincinnati Bargain Store for city taxes for the year 1933; it is, therefore, ordered that the said Cincinnati Bargain Store be, and it is hereby exonerated from the payment of taxes on said assessment for the year 1933, and the said store having paid taxes for said year in the sum of \$5.57, same are ordered refunded to the said Cincinnati Bargain Store. Therefore,

M., August 1, 1934, for the purpose of receiving and acting upon Report of the Budget Commission for the year beginning July 1, 1934, and ending June 30, 1935, and passing an ordinance adopting said Budget Commission's Report, and acting upon application of Mrs. J. S. Miller for building permit.
