At a regular adjourned meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 23rd day of October, 1934, the following were present:

Julien Auxier and Mrs. Harve Damron appeared before the council and asked that the city install water mains from present mains to her property on Poplar Street; and said matter is passed for further consideration.

Upon motion made, duly seconded and carried T. E. Newton, Water Superintendent, is directed to investigate matter of installing water mains from present water mains to Poplar Street, and he shall report result of his investigation to the council at its next regular meeting.

W. T. Griffith appeared before the council and stated that he was in arrears with his water bill, and asked for further time in which to pay same before water is cut off; and the council took no action on same.

Mr. Henry, of the Ashland Refining Company, appeared before the council and stated that an outlet for sewerage on corner of Second Avenue and Scott Avenue could not be found, and asked for permit for said Ashland Refining Company to connect with sewer on Scott Avenue. Upon motion made, duly seconded and carried said permit is granted pursuant to terms of all city ordinances, rules and regulations.

Mr. Showalter appeared before the council and stated that his water rental had been too much, at 803 Cline Street; and upon motion made, duly seconded and carried the water superintendent was directed to install new water meter at said residence for purpose of checking same.

Upon motion made, duly seconded and carried the water superintendent is directed to be present at, and meet with the council, at all regular council meetings.

J. S. Cline appeared in open council and asked that the city carry out terms of deed which he stated he had made it and the State Highway Commission for rights of way over his property on Cline Street, and after discussion, upon motion made duly seconded and carried, said matter is passed until next meeting of council.

Wade Heirs appeared before the council and stated that he did not desire to serve as secretary of the fire department, and action on same was passed until next regular meeting.

A. J. Jackson, Tax Collector, filed settlement as collector of Sidewalk Account, which was for sidewalks built by Albert Bentley on Cline Street, Kentucky Avenue, Park Street and other alleys and intersections, and which settlement showed amounts collected by him, treasurer's receipts therefor, &c.

A. J. Jackson, Tax Collector, filed report of collector's sale for city taxes for year 1933, totaling \$2032.23.
