MINUTES } CITY OF PIKEVILLE

At a regular meeting of the Common Council of the City of Pike-ville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 20th day of November, 1934, the following were present:

Mayor, Councilmen, K. J. Day, and Arthur Fields, G. C. Call, A. S. Johnson, H. E. Syck and

Clyde Childers.

Councilman, Rush Sword, was absent.

O. A. Stump appeared before the council and asked that an ordinance be passed permitting cars to park on right side of Second Street from Grace Avenue to Division Street, and it is suggested and agreed that the curb in front of his garage on Second Street be painted yellow.

T. H. Harman, representing W. P. Call, and W. P. Call appeared before the council with reference to purported obstruction of road on Peach Orchardby stoppage of drain on W. P. Call's lots, and said matter isreferred to the city engineer and street committee, who shall report to the council at its next regular meeting their findings.

G. M. Collins appeared before the council and stated that street paving bill charged to Hester & Lundy Collins had been paid, and that he desired that the street paving books be marked accordingly; and the mayor referred said matter to A. S. Johnson and the City Clerk, who shall investigate said matter and report their findings to the council at its next regular meeting.

J. S. Cline appeared before the council with reference to claim which he claims against the City and Highway Department for rights of way &c on Cline Street; and said matter is passed for further consideration by the council and city attorney.

The mayor appointed A. S. Johnson, Rush Sword and G. C. Call as committee to examine and inspect old city taxes, together with city clerk, and report to the council such taxes as they think are delinquent.

Upon motion of H. E. Syck, duly seconded by Clyde Childers, and unanimously carried, Hon. K. J. Day, Mayor of the City of Pikeville, is hereby authorized and directed to request of the Public Service Commission of Kentucky, at Frankfort, Kentucky, an informal hearing for the purpose of considering reduction of gas rates in the City of Pikeville under franchise now held and operated by Federal Public Service Corporation of Kentucky.

Upon motion made, duly seconded and carried the city clerk is directed to advertise for bids for feeding city prisoners at so much per meal for the period of six months, to be placed in the Pike County News for one issue, and bids to be received up to December 4, 1934.

H. E. Syck moved that all police be directed to check up on tagged stubs issued for violation of parking ordinances after the time specified on the face of the tag for the offender to appear has expired, and the policemen secure warrants and execute same on all parties who have failed at that time to appear. Clyde Childers seconded said motion, which carried.

Upon motion made, duly seconded and carried the city attorney is directed to prepare ordinance relating to parking on Main Street from Pike Street to Grace Avenue, requiring all cars to be parked parallel on right hand side going south; and prepare ordinance relating to parking on Main Street from Caroline Avenue to Huffman Avenue, requiring all cars to be parked parallel on right hand side going south.

Roy Salyers appeared before the council and asked that a new street light be installed on Kentucky Avenue, and said matter is referred to the Utilities Committee.

ORDERED THAT:

T. M. Stratton be, and he is hereby allowed the sum of \$5.83 for freight paid on steel &c for city building by said Stratton, as per invoice of date November 17, 1934, payable out of General Expenditure Budget Fund.

ORDERED THAT:

Federal Public Service Corporation be, and it is hereby allowed the sum of \$3.70 for gas for city hall for month of October, 1934, payable out of General Expenditure Budget Fund.

Upon motion made, duly seconded and carried Council is adjourned until its next regular meeting.
