Stratton, pending in the Court of Appeals of Kentucky, had been affirmed, and asked that the council enter an order paying salaries of certain city officials pursuant to terms of salary ordinance passed in year 1929, in lieu of ordinance passed in year 1931; and council passed said matter for reason that it was not budgted in 1934-1935 budget.

York and wife, transferred to Foster Thornburg Hardware Company by deed, dated January 15, 1919.

Thereupon Councilman Arthur Fields introduced and moved the adoption of the following resolution:

> "Whereas, prior to January 15, 1919, street improvements were ordered made for which certain assessment warrants or bonds were issued against and affecting the title to certain real estate located in said city at the junction of College Street and Huffman Avenue

and adjoining the C & O Railroad Company's right of way, and being the same property mentioned and described in certain deed of conveyance executed by C. C. York and wife to the Foster-Thornburg Hardware Company, dated January 15, 1919, and recorded in Deed Book No. 97, page 92, of the Pike County Court Records, and being also the same property, part of which is now owned by the Sandy Valley Grocery Company (a corporation existing under the laws of Kentucky) and the Foster-Thornburg Hardware Company (a corporation existing under the laws of West Virginia); and

WHEREAS, said warrant or bond amounted to the sum of \$498.87 the payment of which was assumed by the Foster-Thornburg Hardware Company has been paid in full, and said Foster-Thornburg Hardware Company has produced written evidence of the payment of said warrant and bond and has fully satisfied this Council of the full payment thereon, together with all inter-

est thereon: NOW, THEREFORE, in consideration of the premises and especially of the payment of said assessment warrant or bond and all interest thereon, it is now resolved by the City Council of Pikeville, Kentucky, that any and all liens, claims or other interests of said city in or to said real estate as satisfaction or security for the payment of said assessment warrant or bond be, and the same are, now hereby fully released and discharged and the City Treasurer of the City of Pikeville is hereby authorized and directed to make, sign and execute a proper release of said lien on the margin of the record in said deed of conveyance in the Pike County Court Clerk's Office in deed book ninety-seven, page ninety-two, said release to be executed in the name of and for the benefit of the City of Pikeville through its

treasurer aforesaid." Said resolution being placed on its passage, and seconded by Clyde Childers, and vote being taken thereon, said resolution received the unanimous vote of all the members of the City Council present, and the same was thereupon, by the mayor, declared duly adopted.

T. J. Williamson appeared before the council and stated that his water bill was too large and desired that said matter be investigated, and said matter was referred to the Superintendent of Water Department for his attention.

T. H. Williams appeared before the Council and stated that Frank Hopkins had filled up a lot 18 inches or two feet, and that a great deal of same had washed off of said lot and filled up alley running from-Seventh Street west between Scott and Cline Streets, and asked that the council have Mr. Hopkins clean up said alley.

H. E. Syck moved that the city clerk notify Mr. Hopkins/place cinders on said alley and make same passable immediately and in as good condition as it was before he dumped dirt on seme. Clyde Childers seconded said motion, which carried.

Rev. W. E. Donaldson appeared before the Council and stated that the road leading from Julius Avenue upon hill to what is commonly known as "Peach Orchard" was in very bad condition and asked that same be fixed so it could be traveled, and the Mayor stated that same had been placed as a Relief project and hoped to have same hard surfaced, and believed that the city would be able to get this relief immediately.

The Street Cleaner was directed to go to road leading from Julius Avenue to Peach Orchard Knob on Friday, February 8th, and work on said street or road on said day.
