NOW, THEREFORE, in consideration of the premises and especially of the payment of said assessment warrant or bond and all interest thereon, it is now resolved by the City Council of Pikeville, Kentucky, that any and all liens, claims or other interests of said city in or to said real estate as satisfaction or security for the payment of said assessment warrant or bond be, and the same are, now hereby fully released and discharged and the City Treasurer of the City of Pikeville is hereby authorized and directed to make, sign and execute a proper release of said lien on the margin of the record in said deed of conveyance in the Pike County Court Clerk's Office in deed book ninety-seven, page ninety-two, said release to be executed in the name of and for the benefit of the City of Pikeville through its treasurer aforesaid."

Said resolution being placed on its passage, and seconded by Clyde Childers, and vote being taken thereon, said resolution received the unanimous vote of all the members of the City Council present, and

the same was thereupon, by the mayor, declared duly adopted.

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the City Hall in the City of Pikeville, Kentucky, on the 5th day of February, 1935, the following were present:

Councilman, Arthur Fields, was absent.

T. J. Williamson appeared before the council and stated that his water bill was too large and desired that said matter be investigated, and said matter was referred to the Superintendent of Water Department for his attention.

T. H. Williams appeared before the Council and stated that Frank Hopkins had filled up a lot 18 inches or two feet, and that a great deal of same had washed off of said lot and filled up alley running from-Seventh Street west between Scott and Cline Streets, and asked that the council have Mr. Hopkins clean up said alley.

H. E. Syck moved that the city clerk notify Mr. Hopkins/place cinders on said alley and make same passable immediately and in as good condition as it was before he dumped dirt on seme. Clyde Childers seconded said motion, which carried.

Rev. W. E. Donaldson appeared before the Council and stated that the road leading from Julius Avenue upon hill to what is commonly known as "Peach Orchard" was in very bad condition and asked that same be fixed so it could be traveled, and the Mayor stated that same had been placed as a Relief project and hoped to have same hard surfaced, and believed that the city would be able to get this relief immediately.

The Street Cleaner was directed to go to road leading from Julius Avenue to Peach Orchard Knob on Friday, February 8th, and work on said street or road on said day.

Sowards desired permit to erect one story building on Ballard and John Weddington lot on Main Street, known as Fanny Scott lot, immediately next to T. G. Parker's store. A. S. Johnson moved that said permit be granted, same to conform in every respect to all city ordinances, rules and regulations, and to be done under the direction of the City Engineer. H. E. Syck seconded said motion, which carried.

Clyde Childers moved that the City accept the following as minimum for water rates, effective March reading, April billing, 1935, with a minimum of \$1.75 per month; said rates being as follows:

60¢ per M. For the first 3000 gallons, For the next 2000 gallons, 55¢ per M. For the next 5000 gallons, 50¢ per M. For the next 10000 gallons, 45¢ per M. For the next 20000 gallons, 40¢ per M. For the next 20000 gallons, 35¢ per M. For the next 20000 gallons, 30¢ per M. For the next 20000 gallons, 25¢ per M. For all water in excess of the above, or in excess of 100000 gallons, 20¢ per M.

H. E. Syck seconded said Mr. Childers' motion, and that the city attorney prepare ordinance incorporating same, which said motion carried.

V. E. Bevins, City Treasurer, filed financial statement, as of February 5, 1935.

Councilmen, Arthur Fields and H. E. Syck, made the following report:

"Councilmen Arthur Fields and H. E. Syck having heretofore been appointed by the council at its meeting held September 18, 1934, to employ an attorney to assist the City Attorney in defense of action styled James Hatcher and others against Kentucky and West Virginia Power Company and City of Pikeville, said Fields and Syck now report to the council that they employed Henry J. Scott as said attorney to assist the City Attorney in defending the City in the above styled action. Said Scott to be paid fee of \$100.00."

Rush Sword moved that the above report of the committee, Arthur Fields and H. E. Syck, be accepted and that their employment of and agreement on the fee of \$100.00 to be paid Henry J. Scott to assist the City Attorney in defending the above action on behalf of the City of Pikeville be now approved and confirmed. H. E. Syck seconded said motion. Upon roll call the vote was as follows:

Scott, heretofore employed as attorney to assist the City Attorney, in defense of action styled James Hatcher &c vs. Kentucky and West Virginia Power Company and City of Pikeville, Arthur Fields and H. E. Syck, or either of them, are authorized and empowered to verify any or all pleadings deemed necessary to be filed in behalf of the City in the above styled case, by either the City Attorney or Henry J. Scott, attorney employed to assist in the defense of above case."

A. S. Johnson seconded the above motion. Upon roll call the vote was as follows:

J. W. Call appeared before the council and stated that the sewer upon Kentucky Avenue had broken down, and that same should be fixed immediately. Upon motion made, duly seconded and carried said matter was referred to the Street Committee, with instructions to have same fixed immediately.

Roy Owsley, of the Kentucky Municipal League, visited the council in open session and reduction of various utility rates was discussed.

H. E. Syck moved that an order be entered authorizing the Mayor to notify Federal Public Service Corporation, the local gas company, that the city desires a reduction of at least 25% in gas rates at this time, and that if said proposal is not accepted, the city shall proceed with formal complaint. Rush Sword seconded said motion, which carried.
