At a special or call meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the city of Pikeville, Kentucky, on the 14th day of March, 1935, the following were present:

Said meeting was held pursuant to the following call:

"City of Pikeville, Kentucky.
To Clyde Childers, H. E. Syck, A. S. Johnson, Arthur Fields, G. C. Call and Rush Sword, Councilmen of the City of Pikeville, Kentucky:
You and each of you are hereby notified that a special meeting of the Common Council of the City of Pikeville, Kentucky, is hereby called to convene in the city hall in the City of Pikeville, Ky., at 7:30 o'clock P. M., for the purpose of considering, signing and approving contract and lease between Pikeville College, Inc., City of Pikeville, Ky., and T. H. Harman, Frank A. Connolly, A. E. Auxier, John M. Yost and N. A. Chrisman, of date March 14, 1935, and taking any other action regarding same council deems necessary: said contract and lease relating to improving, grading and draining athletic field of Pikeville College, Inc., located at south end of College Street, Pikeville, Ky.

Contract and lease, of date March 14, 1935, between Pikeville College, Inc., party of the first part, The City of Pikeville, of the second part, and T. H. Harman, Frank A. Connolly, A. E. Auxier, John M. Yost and N. A. Chrisman, of the third part, relating to improving athletic field, maintenance of same &c., was presented and read to the Council.

Rush Sword moved that the mayor be authorized and directed to enter into and sign said contract in behalf of the City of Pikeville. H. E. Syck seconded said motion. Upon roll call the vote was as follows:

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 19th day of March, 1935, the following were present:

Representative of Armour & Company appeared in open council and asked for permit for Armour & Company to install gasoline pump on their premises of about 500 gallon capacity between C. & O. railroad track and their building on Pike Street.

Arthur Fields moved that said permit be granted pursuant to terms of all city ordinances, rules and regulations. Rush Sword seconded said motion, which carried.

Chris Petrou, of the New York Restaurant, appeared before the council and asked that a street light be placed at his restaurant on Caroline Avenue; and said matter was referred to the Utilities Committee.

Denny Webb appeared before the council and stated that he owned a lot on Peach Orchard hill, and that J. M. Bowling had fence across public street or roadway, and asked that the council take steps to have same opened.

Upon motion made, duly seconded and carried said matter was referred to the Street Committee and the City Engineer.

George Brooks appeared in open council and requested that police department be directed to mark off place for him to park taxicab in front of Milt Layne's restaurant on Division Street. It was reported to the Council that the officials of the First National Bank stated it would be satisfactory to them to have taxicabs park in front of their building on Division Street, and said Brooks matter was passed for further consideration.

Upon motion made, duly seconded and carried the city attorney was directed to prepare ordinance relating to parking of taxicabs on Division Street between First National Bank Building and the Court-House and present same to council at its next meeting.

S. H. Hunt, Superintendent of Methodist Hospital, by letter requested council to allow no parking at junction of Kentucky Avenue and High Street, for reason cars, ambulances &c desiring to go to hospital did not have sufficient room in which to make turn. Upon motion made, duly seconded and carried said matter was referred to the Chief of police with instructions to mark off same and allow no parking in space marked off.

ORDERED THAT:

A. S. Ratliff be, and he is hereby allowed the sum of \$18.56 for 20% commission on \$92.80 delinquent taxes collected from Belle Williamson, Sadie Cohen and W. E. Elliott, payable out of General Expenditure Budget Fund.

ORDERED THAT:

J. M. Hatcher be, and he is hereby allowed the sum of \$50.00 for payment on attorney fee in case of F. A. Hopkins vs. City of Pikeville, payable out of General Expenditure Budget Fund.

The matter of purported stoppage of sewer on lot of R. C. Elliott on lower Cline Street was discussed, and referred to the city attorney for his advice and recommendation.

The chief of police, T. M. Stratton, again asked that the City Council accept his resignation as city jailer. H. E. Syck moved that said resignation be accepted. Arthur Fields seconded said motion which carried.

E. E. Trivette, Police Judge, suggested the name of Ed Auxier for city jailer and recommended that he be appointed.

Rush Sword moved that Ed Auxier be employed as city jailer at a salary of \$25.00 per month, effective March 19, 1935, but without pay until April 1st, 1935, after which time he is to be paid \$25.00 per month, said term of jailer to expire July 6, 1935. Arthur Fields seconded said motion, which carried unanimously.

Upon motion made, duly seconded and carried the city attorney is directed to write letter to Mr. W. A. Mordica, of the Chesapeake and Ohio Railway Company, asking that said railway company cease blocking traffic on city streets by reason of long trains stopping for too long period of time; and also take up with Mr. Mordica the matter of signals at all railroad crossings in the city.

Upon motion made, duly seconded and carried the city attorney is directed to immediately institute proper suit enjoining O. A. Stump from building or erecting structure on lot owned by city at rear of city buildings, on Division Street.

Upon motion made, duly seconded and carried council is adjourned until its next regular meeting.
