

MINUTES } CITY OF PIKEVILLE

At a special or call meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 22nd day of March, 1935, the following were present:

Mayor, K. J. Day, and
Councilmen, H. E. Syck,
A. S. Johnson, and
Rush Sword, and
Clyde Childers.
Councilmen, Arthur Fields, G. C. Call, were absent.

Said meeting was called and held pursuant to the following call:

"To H. E. Syck, Clyde Childers, Rush Sword, A. S. Johnson, Arthur Fields and G. C. Call, Councilmen of the City of Pikeville, Kentucky:

You and each of you are hereby notified that a special meeting of the Common Council of the City of Pikeville, Kentucky, is hereby called, to convene in the city hall in the City of Pikeville, Kentucky, on the 22nd day of March, 1935, at 7:30 O'clock P. M., for the purpose of entering into contract and lease, of date March 22, 1935, between Pike Country Club, of the first part, the City of Pikeville, party of the second part, and T. M. Watkins, O. W. Thompson, R. E. Doyle, Jr., Walter Hatcher, J. S. Miller and E. A. Starling, of the third part, and authorizing and approving the signing of same on the part of the City of Pikeville, and taking such other action as council deems necessary in connection therewith; said contract being entered into for purpose of improving golf course of first party located about 7 miles south of Pikeville, Ky.

Contract and lease, of date March 22, 1935, between Pike Country Club, party of the first part; the City of Pikeville, party of the second part; and T. M. Watkins, O. W. Thompson, R. E. Doyle, Jr., Walter Hatcher, J. S. Miller and E. A. Starling, parties of the third part, was presented and read in open council, which contract is for purpose of improving golf course of first party.

H. E. Syck moved that said contract be accepted and approved, and the mayor and city clerk be authorized and directed to sign same in behalf of the city. Rush Sword seconded said motion, which carried.

Said contract was signed by the mayor, attested by the city clerk, in open council.

Upon motion made, duly seconded and carried council is adjourned until its next regular meeting.

Councilman, Rush Sword, was absent.

O. A. Stump appeared before the council and asked that parking on Grace Avenue be stopped on north side or side next to his hotel, and that ordinance be passed designating south side of said street as side on which to park; and the council passed said matter for further consideration.

Lease, of date April 2, 1935, between Pike County Club, of the first part, and City of Pikeville, of the second part, by which first party leases to second party golf course, was presented and read to the Council.
