Upon motion made, duly seconded and carried Clyde Childers is granted permit to erect two story brick building on Scott Avenue on North side thereof, and to connect with city sewer, pursuant to terms of all city ordinances, rules and regulations.

Letter from O. T. Hinton, Attorney for Mrs. J. R. Johnson, stating that alley at rear of her property on College Street was be coming filled up, &c was read to the council, and said matter was referred to the Street Committee.

H. E. Syck moved that the city clerk notify Mrs. Loraine Chaney that her services as clerk of the water department will be discontinued as of the 30th day of June, 1935, and that she be paid for the full month of June, 1935. A. S. Johnson seconded, which carried.

H. E. Syck moved that the city attorney be authorized and directed to institute injunction proceedings in behalf of the City against Hi Pauley for installing lumber shed and storing lumber on the Gray & Bowles property on Second Street, and that the city clerk be authorized and directed to issue warrant for \$5.50 advance cost. Said motion was duly seconded and carried.
