

MINUTES } CITY OF PIKEVILLE

ORDERED THAT:

G. S. Thornbury be, and he is hereby allowed the sum of \$18.00 for serving as member of board of supervisors for year 1935, payable out of General Expenditure Budget Fund.



The mayor in behalf of the City of Pikeville, and Alfred F. Lewitt, signed said contract.



At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 3rd day of September, 1935, the following were present:

Mayor, K. J. Day, was absent, but the following Councilmen, H. E. Syck, Arthur Fields, A. S. Johnson and G. C. Call, were present.

Councilmen, Clyde Childers and Rush Sword, were absent.

Upon motion made, duly seconded and carried H. E. Syck was elected Mayor Protem, and accepted the duties as such.

D. J. Vanhooze, truant officer for Pikeville High School, appeared before the council and asked that a traffic light be placed at corner of Fourth Street and Auxier Avenue, near Pikeville High School.

A. S. Johnson moved that the Kentucky and West Virginia Power Company be directed to install one traffic light at intersection of Fourth Street and Auxier Avenue in the City of Pikeville. Arthur Fields seconded said motion, which carried.

Councilman, Clyde Childers, is now present.

A. S. Johnson moved that G. C. Call be appointed as committee to have two zone signs painted near Pikeville High School and make contract for same. Arthur Fields seconded said motion, which carried, and the mayor appointed said G. C. Call as committee of one to carry out said request.

Denny Webb appeared before the Council and requested that a certain street be opened up on Peach Orchard Hill, and said matter was referred to the Street Committee.

Sidney Trivette appeared before the council and stated that sometime ago the street cleaner cut the curb into on Riverview Drive, thereby turning the water into his property; that it was damaging his property and also washing away the street, and he asked that said matter be given immediate attention.
