At a regular adjourned meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 8th day of October, 1935, the following were present:

Mayor, K. J. Day, and
Councilmen, Clyde Childers,
Arthur Fields, and
H. E. Syck.

Councilmen, Rush Sword, A. S. Johnson and G. C. Call, were absent.

Mrs. J. W. Langley appeared in open council and asked that the water mains be extended across river to the property of herself and others, and said matter was referred to T. E. Newton, water superintendent, with instructions to report to the Council at its next regular meeting.

F. L. Rice, representing United Carbon Company, appeared in open Council and made application for United Carbon Company to lay gas pipe line under Cline Street, same to be four inch pipe line and hole bored under street (welded pipes); to go under street at the first alley above Riverview Drive, being about 100 feet above Riverview Drive where it crosses the railroad and street, and filed plat showing proposed location of said pipe line.

Upon motion made, duly seconded and carried the United Carbon Company was granted permit to lay pipe line, as described in above order, pursuant to terms of all city ordinances, rules and regulations.

Upon motion made, duly seconded and carried the city attorney was directed to prepare proper ordinance relating to laying of pipe lines &c under city streets, and present same to the council at its next regular meeting.

Mr. Gibson, representing the Daily News and Pike County News, appeared before the council with reference to City projects to be had from the Government, which matters were discussed generally.

H. E. Syck introduced an ordinance entitled "AN ORDINANCE PROVIDING FOR THE SUBMISSION TO THE QUALIFIED VOTERS OF THE CITY OF PIKEVILLE, KENTUCKY, AT THE REGULAR ELECTION TO BE HELD NOVEMBER 5, 1935, OF THE QUESTION WHETHER THE CITY OF PIKEVILLE SHALL INCUR AN INDEBTEDNESS IN THE SUM OF \$33,000.00 AND ISSUE AND SELL ITS FOUR PER CENTUM (4%) BONDS IN SAID SUM THEREFOR TO PROVIDE FUNDS FOR THE PURPOSE OF PAYING THE COST OF CONSTRUCTING STORM SEWER SYSTEM, SUCH BONDS AND THE INTEREST THEREON TO BE PAID BY THE LEVY OF A TAX BY THE CITY OF PIKEVILLE, EACH YEAR FROM THE YEAR OF 1936 TO THE YEAR OF 1955, INCLUSIVE", and moved that said ordinance be passed, approved and adopted. Arthur Fields seconded said motion. Upon roll call the vote was as follows:

The mayor declared said motion carried and said ordinance duly passed, approved and adopted.

Upon motion made, duly seconded and carried Judge Lewis was granted permit to build garage on his lot on College Street, pursuant to terms of all city ordinances, rules and regulations.

Upon motion made, duly seconded and carried Clyde Childers was granted permit to erect one story tile-stucco residence on Wright Alley, same to be done pursuant to terms of all city ordinances, rules and regulations.

Lease, of date 20th day of September, 1935, from The Chesapeake and Ohio Railway Company to City of Pikeville, Kentucky, leasing a parcel of land to City of Pikeville for street purposes at the rate of \$1.00 per year, was presented and filed.

Upon motion made, duly seconded and carried Council is adjourned until its next regular meeting.
