MINUTES | CITY OF PIKEVILLE

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 4th day of February, 1936, the following were present: Mayor K. J. Day, and Councilmen, Dr. R.S. Johnson, Mahlon Hall, Uhlan Taylor, G. C. Call. T. E. Rogers and W. C. Saunders were absent.

ORDERED THAT:

The City Clerk make an aduit of all delinquent taxes for the years 1931, 1932, 1933, 1934 and turn same over to A. J. Akers, City Tax Collector, and take receipts for same.

ORDERED THAT:

The Tax Collector of the City of Pikeville, A. J. Akers, after making diligent efford to collect said delinquent taxes and upon failure to do so, to turn same over to the City Attorney for collection and that the City Attorney is hereby authorized and empowered to institute any and all actions in Courts of competent jurisdiction for the collection of said taxes.

The City Clerk filed a receipt from A. J. Akers, Tax Collector, for 1934 tax books, which is in words and figures as follows:

"Pikeville, Kentucky, February 4, 1936. Received of Chas. R. Epperson, City Clerk, tax books for the year 1934 containing delinquent tax tickets, in words and figures as follows: Four tax books containing tax tickets in the sum of \$1,959.20. This February 4, 1936. A. J. Akers, Tax Collector."

Orville Clark, having made complaint as to the amount of his water bill being excessive due to frozen and bursted pipes and asking the City Council that he be exonerated in the sum of \$4.14,

ORDERED THAT:

Orville Clark be exonerated in the sum of \$4.14 on his water bill for the month of January.

ORDERED THAT:

The settlement of Marvin Stratton, past Chief of Police, made with the former City Clerk, John M. Hatcher, be and the same is hereby confirmed.

Councilman W. C. Saunders is now present.

James M. Hatcher, having made complaint relative to the lighting of Locust Court and after hearing same read, it is ordered that the City Attorney notify the Kentucky & West Virginia Power Company to install a light in the most appropriate and effective place at or near said Locust Court and that the placing of said pole be upon city property, if possible.

Christ Petrou, having made complaint relative to requiring separate bond on beer and whiskey, same being duscussed, action was deferred indefinitely on same.

Oscar Sowards, having made complaint relative to the changing of a light on High Street and after a discussion os same, same was referred to the Committee on Utilities. The Utilities Committee, having discussed the matter, recommended that the change be made and that the City Attorney give notice to the Kentucky & West Virginia Power Company authorizing them to make said change.

Mayor K. J. Day suggested that the Council, City Clerk, City Attorney and himself have a meeting sometime soon for the purpose of going through all the delinquent tax books and weeding out those that cannot be collected and offering any suggestions relative to collecting the remainder.

ORDERED THAT:

Dave Weddington be allowed a renewal of his beer license and that the bond offered by him with Sam Caudill as surety be accepted.

ORDERED THAT:

The personal bond of V. E. Bevins, which was tendered and filed, in the sum of \$10,000 with J. T. Moore and Geo. W. Coleman, sureties thereon, be and the same is hereby accepted.

ORDERED THAT:

Louis' Cafe be paid the sum of \$11.00 for meals served to Kentucky & West Virginia Power Company men while engaged in thawing out city water pipes for the City of Pikeville, to be paid out of the water department fund. Further, that a letter of thanks be published in the Daily News of the City of Pikeville in appreciation of the favor shown to the City by the Power Company in the voluntary services that they rendered in assisting the City in thawing out frozen mains and water pipes.
