W. C. Sanders moved that the Mayor appoint a purchasing committee to buy a right-of-way on Eighth Street for W. P. A. street project. The Mayor appointed W. C. Sanders, Dr. R. S. Johnson and T. E. Rogers on this committee.

RESOLVED THAT: Be it resolved that, when any ordinance is introduced to the City Council, that the same be prepared with sufficient copies so that each member of the City Council and the Mayor may have a copy; that a vote shall not be taken on any measure or ordinance the same night that same is introduced but that sufficient time be given for each member to study same and understand the merits thereof before the adoption of same, except ordinances containing an emergency clause which may be passed the same night introduced.

## WHEREAS:

Some time intervened between the time of filing an application for a bond with the National Surety Corporation for Floyd Bevins, Chief of Police, until the same was received, and whereas the said Floyd Bevins executed a personal bond for the intervening time with Jack Akers and Richard Thompson as sureties on said bond, and whereas the bond from the National Surety Corporation has been received and accepted by the City Council, it is therefore ordered by the City Council that the said Jack Akers and Richard Thompson be, and they are, hereby released as sureties on said bond.
