ORDERED THAT:
V.E.bevins City treasurer pay to Bessie R. Arnold, County Court Clerk the sum of \$52.07 Amount of City Tax, paid by A.S.Ratliff City Attorney on June the 8th 1934. to said Bevins, for 1932, City Taxes of James Marrs. BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PIKEVILLE, KENTUCKY.

SECTION- 1- That all persons convicted of crime, in the Police court of the City of Pikeville, Kentucky. wherein such persons are required by such conviction, to pay a fine,

ORDERED THAT,

The Mayor and City Jailor be empowered to and they are hereby authorized to sign a contract with the United States of America, relative to the use of the City Jail of Pikeville, Ky, by the United States Government.

ORDERED THAT:

V. E. Bevins City Treasurer, is hereby directed to transfer from the General Water department funds, To second Street paving funds, the sum of Twenty-five Hundred Dollars.

ORDERED THAT:

The works repaving second street, and widening it two feet on each side, from its intersection with Huffman Avenue to its intersection with Pike Avenue and rebuilding sidewalks along said portion of second street. all work to be done of concrete in conjunction with W. P. A. be started at once.

ORDERED THAT:

The First National Bank of the City of Pikeville, Ky. is hereby permitted at its own request to rebuild the sidewalk in front and at the side of said bank building, at the expense of said Bank.

ORDERED THAT:

The Coca Cola bottling Co. and F. W. Owens, contractor, be allowed to build a bottling plant on three lots on Cline street, at steel street, for the Coca Cola bottling Company.

ORDERED THAT:

Mary Pauley be paid the sum of \$26.88 refund on City Taxes on years 1931-1932-1933. tax on Joe Justice lot, paid twice. Payable out Gen funds.
