The Kentucky Municipal League be and it is hereby allowed the sum of \$33.76 for the Cities dues to the League for 1939. Payable out of General Expenditure funds.

\$7.50 Per-Month for rent Payable to Robert Williams, "Landlord" For housekeeping Aide, be made out payable on the 20th of each Month, until June 20" 1939. Payable out of General expenditure funds.
