

MINUTES | CITY OF PIKEVILLE

A SPECIAL MEETING OF THE CITY COUNCIL OF THE TOWN OF PIKEVILLE, KENTUCKY, WAS HELD IN THE CITY HALL AT 1:00 O'CLOCK, IN THE AFTER NOON ON FRIDAY, SEPTEMBER 1st. 1939.

The Mayor Hi Pauley being absent, from the City, Hayes Jones, was unanimously elected by the councilmen present to act as chairman of the meeting and as Mayor Pro tem.

Thereupon H.S. Damron, Clerk, read the call of the meeting by Hi Pauley, Mayor, on which the return of the Chief of Police shows due execution thereof upon all the councilmen, said call is as follows.

A special meeting of the Common Council of the City of Pikeville, Ky., will be held in the City Hall, at 1 P.M. (E.S.T.) on Friday, September 1, 1939. Necessary action will be taken in connection with Main Street from the court house square to the south end of Main Street, in connection with the abandonment of water Street from opposite the lower line of the old York property (now property of Pike County) near the court house, up along the river bank to the intersection of Water Street with the Bowles heirs lot, and other matters of public interest will be considered. Will you please be present.

Thereupon the chairman directed the names of those present to be noted as above.

Thereupon Charles Childers introduced an ordinance entitled "AN ORDINANCE DEFINING THE SOUTHEAST LINE OF MAIN STREET, RECITING THE FORMER PUBLIC USE OF SUCH STREET, AND FORMALLY ACCEPTING SAME BETWEEN CAROLINE AVENUE AND HUFFMAN AVENUE"; and moved its adoption.

It was thereupon declared by the council that an emergency existed, and the council proceed with an immediately consideration of this ordinance. The motion was seconded by Charles Sowards, and after discussion thereof and comparing same with the map prepared by O.S. Batton for the transfer of the Jerry Robinson property to the United States and other maps of the City, the question was called for and the vote taken resulted as follows:

The Chairman thereupon declared said ordinance duly adopted, and indorsed same with the date and his signature.
