AT A REGULAR COUNCIL MEETING OF THE COMMON COUNCIL OF THE CITY OF PIKE*
VILLE, FEID ON TUESDAY, NOVEMBER 18th, 1941, AT 7:30 P. M., IN THE CITY HALL,

Due to the unaboldable absence of the City Clerk, on motion made and seconded, the city attorney, J. M. Auxier, is directed to keep the minutes of the meeting and to prepare same in the usual form.

Mayor Hi Pauley called the meeting to order from the chair.

Pursuant to ordinances and the following notice,

City Hall in Pikeville, Kentucky, the board of Council will receive bids for \$48,000.00 of city of Pikeville Bonds authorized at the November election, 1941. Bonds will mature serially and price. Certified check for \$1,000.00 must accompany bid of each bidder.

This November 8, 1941.

Mayor Pauley called for bids on the City of Pikeville playground and park bonds. The following sealed bids were personally tenered to Mayor

Pauley, as follows:

1. Joint bid of Stein Bros. & Boyce of Louisville, Kentucky and Pikeville National Bank and Trust Company, dated November 18, 1941, at \$1,000.40 per \$1,000.00 principal amount of bonds, the bonds to carry to carry the following coupon rates:

2. Alternate joint bid of Stein Bros. & Boyce, Louisville, Kentucky and Pikeville National Bank and Trust Company, dated November 18, 1941, which bidwas \$1,012.52, per \$1,000.00 principal amount of bonds, bonds to carry the coupon rate of 3%. This alternate bid was accompanied by certified check of Stein Bros. & Boyce No. A-31844, dated November 15, 1941, payable to order of City of Pikeville Kentucky, drawn on Liberty National Bank and Trust Company, Louisville, Kentucky, in amount of \$1,000.00, marked "Good faith check on bid for \$48,000.00 City of Pikeville, Ky. play ground and park bonds"; same drawn by Stein Bros. & Boyce, counter-signed C. A. Lucas and C. G. Hamond, certified on November 15, 1941, No. 99, signed C. L. Hetch, teller, and R. G. Bickel, cashier; marked "Do not destroy". The notice dated November 8, 1941, signed by H. S. Damron, clerk, which appeared in the November 11, 1941 edition of the Louisville Courier Journal was attached to said check.

4. Bid of the Weil, Roth and Irving Company, Cincinnati, Ohio, dated November 18, 1941, was \$48,120.00 at 31% per annum interest was personally presented by said company's Mr. H. R. Dittus, authorized agent, said bid accompanied by a certified check for \$1000.00, No. D-10606.

The mayor called for additional bids but there were none.

Discussion was had in all of the above/prospective bids.

Councilman Hayes Jones made a motion that the joint alternate bid of Stein Bros, and Boyce and Pikeville National Bank and Trust Company, dated November 18, 1941, at \$1,012.52 per \$1,000.00 principal amount of bonds, the bonds to carry coupon rate of 3%, be accepted. Councilman Charles Childers seconded the motion to accept said bid. The clerk pro tem called the roll, and the vote to accept the above bid resulted as follows:

The report of H. S. Damron showing the advertising of the election was filed, and the same is ordered to be spread at large on the minute bood. Said report is in words and figures as follows:

"STATE OF KENTUCKY I

I, H. S. Damron, City Clerk of the City of Pikeville, do hereby respectfully report to the board of council that the notice hereto attached, giving notice of the holding of the election on the 4th day of November, 1941 on the question of incurring an indebtedness for the purchase of the Bowles property for park and playground by the City of Pikeville, was duly posted by me on the 17th day of October, 1941; one on the bulletin board on Division Street in front of the city hall; one on a light pole on Division Street between Second Street and Main Street; one on a light pole on Third Street near Scott Avenue; and I further caused a copy of such notice to be published in two consective issues of The Pike County News, a weekly paper published im Pikeville in its issues of the 23rd and 30th of October, 1941.

All of which is respectfully reported to the board of council and certified in my official capacity for the use, information and reliance of all bidders for said bonds.

The Council ordered:

1. That the two certified checks of Nelson, Browning and Company, Cincinnati, Ohio for \$500.00 each numbered 19,875 and 19,876, respectively, be returned to Mr. R. G. Howes, agent; and Mayor Pauley handed said checks back to Mr. Howes at the meeting.

2. Ordered that the \$1,000.00 certified check No. D-10606 of the Weil, Roth & Irving Company, Cincinnati, Ohio, be returned to H. R. Dittus, authorized agent of said firm, and Mayor Pauley returned said check to Mr. Dittus at the meeting.

The following ordinance was passed,

"AN ORDINANCE PROVIDING FOR THE LETTING OF A CONTRACT? BY THE CITY OF PIKEVILLE, UPON COMPETITIVE BIDS, TO THE LOWEST RESPONSIBLE BIDDER, FOR THE PURCHASING OF A STANDARD TWO-DOOR SEDAN, OR FOUR DOOR SEDAN FOR A POLICE CAR".

Each of the councilmen present voted "yes" on passing above ordinance.

Ordered that: the City Clerk run advertisement in Pike County News, calling for bids on Police Car, to be opened Nov. 28, 1941.
