At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the City Hall in the City of Pikeville, Kentucky, on the 20th day of January, 1942, the following were present:

The minutes of the meeting of January 6, 1942, were read and approved.

The mayor, M. D. Flanary, read to the Council a letter from the City of Barbourville, Kentucky, with reference to passage of resolution regarding utility plants, etc.

Charles E. Childers introduced said resolution and moved that same be passed and adopted, which said resolution is in words and figures as follows:

"Be it resolved by the Board of Council, and the Officers of the City of Pikeville, Pike County, Kentucky, that:

Whereas, this city has expended considerable money and incurred certain obligations in the purchase of utility plants and equipment for the city, in view of the present municipality and its citizens the benefits of such purchases.

We are firmly and unanimously opposed to any legislation which would extend the jurisdiction of the Public Service Commission to munisipal plants, or that would in any way subject such plants to further control by or liability to the commission, other than such control and liabilities as may now exist under the present law, and we earnestly protest any further attempts which may be made to alter existing law to this effect.

This 20th day of January, 1942."

F. H. Sharp seconded the above motion of Mr. Childers, which carried unanimously.

The mayor called for report of city attorney with reference to public liability and proper damage insurance of city car and Workmen's Compensation insurance. The city attorney reported orally, and said matter is passed until the next regular meeting of the Council for further action.

Upon motion made, duly seconded and unanimously carried the city attorney is authorized and directed to procure public liability and property damage insurance for city police car.

Upon motion made, duly seconded and carried, it is ordered that the following salaries shall stand allowed to the following parties, and the city clerk is authorized and directed to pay same on the first day of each month (except when the last day of the month falls on Sunday, and then the clerk may issue warrants therefor on the preceding Saturday or the following Monday); which said monthly salaries are as follows:
