Workmen's Compensation policy No. W.C. 107834 of Bituminous Casualty Corporation, effective February 4, 1942, covering various city employees of the City of Pikeville was presented, and upon motion made, duly seconded and carried same was accepted.

Policy No. SMC-9587 of the United States Fidelity and Guaranty Company of Baltimore, Md., through Francis, Francis & Trivette, Inc., City, covering operation insurance for Gas and Water Works plants, for one year from February 5, 1942.

Three bids for cleaning of streets, disposal of garbage &c., of the city, were received by the city clerk, opened and read to the Council; and upon motion made, duly seconded and carried Council passed same until the next regular meeting of the Council for consideration.
