The minutes of the meeting of May 19, 1942, were read and approved.

It appearing that the semi-annual interest on city park and play ground bonds is due during months of May and November, 1942, totaling \$1440.00, T. J. Howell moved that the city treasurer be authorized and directed to borrow from Water Works Funds, not otherwise appropriated, the sum of \$1440.00 with which to pay said interest. F. H. J. C. Williamson, City Jailer, filed report for month of May, 1942, showing number of city prisoners, number of days same were kept in city prison, and number of meals furnished them.

J. C. Williamson, City Jailer, filed report for month of May, 1942, showing number of federal prisoners kept in city jail for said month, number of days kept in said jail, and number of meals furnished.

T. E. Newton, Superintendent of Water Works Department, filed report showing receipts and disbursements for month of April, 1942, as follows: Receipts, \$2850.11; disbursements, \$900.14; balance, \$1949.97.

T. E. Newton, Superintendent of Gas Department, filed report showing receipts and disbursements for month of April, 1942, as follows: Receipts, \$4464.27; disbursements, \$3221.26; balance, \$1243.01.

E. E. Trivette filed report as Police Judge for month of May, 1942, showing receipts and disbursements for said month, as follows: Receipts, \$760.30 (including 102 parking meter violations, \$102.00); paid out, \$223.50; due the city, \$536.80.

Upon motion of T. J. Howell, duly seconded by Charles E. Childers and unanimously carried, the following order was entered:

"WHEREAS, on November _____, 1931, the City of Pikeville, Kentucky, by its Common Council, under and pursuant to proper ordinances enacted by it, assessed property, owned by A. J. Cox, R. C. Shupe and R. L. Williamson, on Jefferson Street, in the City of Pikeville, with Street Improvement liens, as follows: A. J. Cox, in the sum of Four Hundred Ninety Three and 85/100 (\$493.85) Dollars; R. C. Shupe, in the sum of Two Hundred Eighty-Six and 35/100 (\$286.35) Dollars, and R. L. Williamson in the sum of Two Hundred Seven and 50/100 (\$207.50) Dollars; that the City of Pikeville, Kentucky, issued its Street Improvement Bonds for said amounts, due and payable from one to ten years from date of said bonds, and attached thereto coupons for the amount of interest due on each bond at all interest paying periods; that these bonds were turned over to J. E. Stanley, together with other bonds, in payment of the contract price for the improvement of said Jefferson Street; that there was collected by the City of Pikeville, Kentucky, through its treasurer, on the A. J. Cox assessment, the sum of One Hundred Forty-Eight and 16/100 (\$148.16) Dollars, on the principal of said bonds, and Eighty-One and 86/100 (\$81.86) Dollars, as accrued interest; that there was collected by the City of Pikeville, Kentucky, through its treasurer, on the R. C. Shupe assessment, the sum of Fifty-Three and 85/100 (\$53.85) Dollars, as interest on said bonds; that thereafter, the said
