Childers and unanimously carried, the following order was entered: "WHEREAS, on November , 1931, the City of Pikeville, Kentucky, by its Common Council, under and pursuant to proper ordinances enacted by it, assessed property, owned by A. J. Cox, R. C. Shupe and R. L. Williamson, on Jefferson Street, in the City of Pikeville, with Street Improvement liens, as follows: A. J. Cox, in the sum of Four Hundred Ninety Three and 85/100 (\$493.85) Dollars; R. C. Shupe, in the sum of Two Hundred Eighty-Six and 35/100 (\$286.35) Dollars, and R. L. Williamson in the sum of Two Hundred Seven and 50/100 (\$207.50) Dollars; that the City of Pikeville, Kentucky, issued its Street Improvement Bonds for said amounts, due and payable from one to ten years from date of said bonds, and attached thereto coupons for the amount of interest due on each bond at all interest paying periods; that these bonds were turned over to J. E. Stanley, together with other bonds, in payment of the contract price for the improvement of said Jefferson Street; that there was collected by the City of Pikeville, Kentucky, through its treasurer, on the A. J. Cox assessment, the sum of One Hundred Forty-Eight and 16/100 (\$148.16) Dollars, on the principal of said bonds, and Eighty-One and 86/100 (\$81.86) Dollars, as accrued interest; that there was collected by the City of Pikeville, Kentucky, through its treasurer, on the R. C. Shupe assessment, the sum of Fifty-Three and 85/100 (\$53.85) Dollars, as interest on said bonds; that thereafter, the said A. J. Cox, R. C. Shupe and R. L. Williamson defaulted in their Street Paving Assessments, and J. E. Stanley, the holder of said bonds, instituted action against each of them in the Pike Circuit Court to enforce collection of the Street Paving Assessments made against their property by the City of Pike-ville, Kentucky, and that the said J. E. Stanley collected by said actions the remainder due on said assessments, as follows, to-wit:

A. J. Cox, \$345.69 principal, and all interest due;
R. C. Shupe, 286.35 principal, and all interest due;
R. L. Williamson, \$207.50, principal, and all interest due,
making a total sum collected by J. E. Stanley on the principal of said bonds,
in the amount of Eight Hundred Thirty-Nine and 54/100 (\$839.54) Dollars, together with whatever amount of interest was due on said bonds, at the time
of collection;

IT IS, THEREFORE, ordered and directed by the Common Council of the City of Pikeville, Kentucky, that J. E. Stanley surrender to the City Treasurer of the City of Pikeville, Kentucky, Street Improvement Bonds, above referred to, which were issued by the City of Pikeville, Kentucky, for the improvement of Jefferson Street, and turned over to J. E. Stanley in payment of the contract price for said improvement an amount of bonds equal to the amount collected by him, from A. J. Cox, R. C. Shupe and R. L. Williamson, in the sum of Eight Hundred Thirty-Nine and 54/100 (\$839.54) Dollars, and that V. E. Bevins, the City Treasurer, is hereby directed to present said bonds in said amount to the Common Council of the City of Pikeville, Kentucky, at its next regular meeting, and that he mark said bonds "Cancelled, Paid in full to J. E. Stanley."
