The Mayor declared said motion carried.

At a regular meeting of the Common Council of the City of Pikeville, Kentucky, convened and held in the city hall in the City of Pikeville, Kentucky, on the 21st day of July, 1942, the following were present:

Mrs. Hester Coleman appeared before the Council and stated that the Board of Supervisors for year 1942 had raised her assessment in the sum of \$500.00, and asked that her tax ticket be exonorated to that extent, and the Council passed said matter for further consideration.

J. C. Williamson, City Jailer, presented check of J. M. Moore, U. S. Marshall, for keeping federal prisoners for month of June, 1942, in the sum of \$32.40, which is directed to be turned over to the City Treasurer.

Written resignation of Madge C. Walters, of date July 8, 1942, as clerk of utilities was presented and read to council, and upon motion made, duly seconded and carried said resignation was accepted.

Written resignation of Lucille Sword, of date July 21, 1942, as clerk of utilities was presented and read to council, and upon motion made, duly seconded and carried said resignation is passed over for further consideration.

Application of Nehi Bottling Company, of Paintsville, Ky., to sell beer as distributor, for year beginning July 1, 1942, and ending June 30, 1943, and upon motion made, duly seconded and carried said application and bond are accepted and approved, and the clerk is directed to issue license accordingly.

J. K. Hatmaker introduced an ordinance entitled "AN ORDINANCE LAYING AN AD VALOREM TAX LEVY ON ALL TAXABLE PROPERTY WITHIN THE CITY OF PIKE-VILLE, KENTUCKY, FOR CITY PURPOSES GENERALLY, FOR THE YEAR 1942; FIXING THE RATE THEREOF; PROVIDING FOR MAKING UP TAX TICKETS, AND THE COLLEC-TION THEREOF; " and moved that said ordinance be passed and adopted. F. H. Sharp seconded said motion. Upon roll call the vote was as follows:

Walter Walters seconded said motion. Upon roll call the vote was as follows:

Walter Walters seconded said motion. Upon roll call the vote was as follows:

Walter Walters moved that the following be appointed as Budget Committee for the year 1942-1943: Mayor, M. D. Flanary; City Clerk, John M. Hatcher; City Treasurer, V. E. Bevins, and Councilmen, Charles E. Childers and T. J. Howell. F. H. Sharp seconded said motion, which carried unanimously

Dick Campbell, representative of the Fabric Fire Hose Company, of Columbus, Ohio, appeared before the City Council and discussed with it the sale of fire hose and fire pump; and said matter is passed for further consideration.

ORDERED THAT:

W. B. Thompson be, and he is hereby allowed the sum of \$40.00 for finishing cards to property maps of city, payable out of General Expenditure Budget Fund.

ORDERED THAT:

T. M. Stratton be, and he is hereby allowed the sum of \$13.00 for services of six men working on sewer, as per invoice of date July 21, 1942, payable out of General Expenditure Budget Fund.

ORDERED THAT: Charles E. Childers be, and he is hereby allowed the sum of \$75.00 for deficit of Fourth of July Celebration Committee for the year

1942, payable out of General Expenditure Budget Fund. Upon motion made, duly seconded and carried council is adjourned until its next regular meeting.
