

MINUTES } CITY OF PIKEVILLE

At a regular semi-monthly meeting of the common council of the City of Pikeville, Kentucky convened and held in city hall on the 24th. day of April, 1961, at 7:30 p.m. the following were present:

The city clerk read the minutes of the previous meeting. Upon completion the Mayor ask if there be any corrections or additions. The council having voiced no objections the Mayor declared the minutes approved as read.

Mrs. Yarus and Katherine Langley Hinton, representatives of the Clean-Up Drive appeared before the council and ask that the ordinance prohibiting spitting on the sidewalks be passed on at this meeting. The city attorney, Dan Jack Combs read the ordinance ; after the city attorney completed the reading the council ask to go into an executive session in the Utilities Office. After doing so and reporting back, J. A. Shockey moved that the ordinance entitled, "AN ORDINANCE PROHIBITING SPITTING ON THE SIDEWALKS OF THE CITY OF PIKEVILLE AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF," be adopted as read. After the City Attorney read the ordinance entitled, "AN ORDINANCE RESTRICTING AND PROHIBITING THE DUMPING OF GARBAGE, REFUSE, TRASH, AND DEBRIS ON THE PROPERTY SITUATED AT THE MOUTH OF LOWER CHLOE CREEK AT THE INTERSECTION OF THE PIKEVILLE BY-PASS AND LOWER CHLOE CREEK ROAD, IN PIKEVILLE, KENTUCKY, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF"; W. T. Huffman moved that the ordinance be adopted as read. J. A. Shockey seconded the motion and the vote was as follows:
