MINUTES } CITY OF PIKEVILLE

At a regular monthly meeting of the Board of Commissioners of the City of Pikeville, Kentucky convened and held in the city hall on the 9th day of April 1962 at 7:30 p.m. The following officials were present:

The city clerk read the minutes of the previous meeting. Upon completion the mayor asked if there by any corrections or objections. The Commissioners having voiced no objections the Mayor declared the minutes approved as read.

The City Manager reported on investigation of blocking of traffic by trucks of Eastern Kentucky Beverage Co. while loading and unloading; the City Mananger stated that they were cooperating to the best of their ability due to conditions to help keep down traffic conjestion.

The City Manager reported that the Chief of Police has been checking on the report of speeding on Sycamore Street.

The Mayor stated that he was reading an ordinance pertaining to license and occupational fees and that this meeting would be postponed to a date in the near future when all members of the Board of Commissioners would be present to pass the ordinance; and, requested that the ordinance be published in the Pike County News as a matter of information. The ordinance read by the Mayor is entitled: AN ORDINANCE IMPOSING LICENSE FEES UPON ALL PERSONS ENGAGED IN ANY TRADE, OCCUPATION OR PROFESSION WITHIN THE CITY OF PIKEVILLE, WHO ARE EMPLOYED BY OTHERS, MEASURED BY ONE PERCENT (1%), OF GROSS RECEIPTS: UPON ALL PERSONS ENGAGED IN ANY TRADE, OCCUPATION OR PROFESSION FOR PROFIT, OR GAIN, MEASURED BY ONE PERCENT (1%), OF NET PROFIT; DEFINING TERMS: PROVIDING FOR THE REGULATION, ADMINISTRATION, ENFORCEMENT AND COLLECTION OF LICENSE FEES FOR THE PURPOSE THEREOF: PROVIDING EXEMPTION FROM LIABILITY FOR LICENSE FEES FOR DOMESTIC SERVANTS; IMPOSING UPON EMPLOYERS THE DUTY TO WITHHOLD, REPORT AND PAY LICENSE FEES OF EMPLOYEES; PROVIDING PENALTY FOR VIOLATION OF THIS ORDINANCE: PROVIDING SEVERABILITY CLAUSE; PROVIDING EFFECTIVE DATES; AND REPEALING CLAUSE.

The Mayor and City Commissioners answered questions relating to this ordinance asked by various citizens of the City that were present at the meeting.

Various citizens were present and voiced their objections to the present flow of traffic across the middle bridge. The commissioners said that the flow of traffic would last 30 days as is now; and then may be changed to one-way coming into town for a 30 day trial period.

B. P. Bogardus moved to temporarily adjourn the meeting until April 16, 1962. R. G. Wells seconded the motion and the vote on the motion was as follows:
