


MINUTES } CITY OF PIKEVILLE



Mayor, Dr. W. C. Hambley, stated the clerk would dispense with the reading of the minutes due to present meeting being a continuation and the minutes were read at that meeting of July 9th, 1962.

John Ward, editor and publisher of Pike County News, presented to the Board of Commissioners and Mayor an affidavit, State of Kentucky, County of Pike, the affiant, Ostice W. Layne, which stated that 32 signatures of petition filed with the Board of Commissioners, City of Pikeville, at their regular meeting Monday, July 9th., 1962, requesting the Commissioners to pass, adopt and enact an ordinance repealing the ordinance enacted by Commissioners May 14, 1962, as amended by ordinances passed June 11 and June 30, 1962; signed said petition in his presence, showing themselves to be residents of Pikeville, Pike County, Kentucky. Affidavit dated July 16, 1962, notarized by Nell S. Burke, Notary Public. Affidavit was accepted by Commissioners.

Mayor Hambley presented and read in its entirety, the following resolution:

The petition presented by John Ward at the regular meeting of the Board of Commissioners held on July 9, 1962 calling for repeal of the Ordinance providing Occupational License Taxes passed on May 14, 1962 as amended having been passed to this adjourned meeting and having been presented by the Mayor for consideration and action thereon by the Board of Commissioners, the following resolution was presented and read:

Be it resolved that:

WHEREAS the petition presented by John Ward at the regular meeting of the Board held on July 9th, 1962, calling for repeal of the Ordinance of May 14th, 1962 as amended, providing and imposing certain Occupational License Taxes, specifically states that it is presented pursuant to the provisions of K.R.S. 89.250, and,

WHEREAS it appears that K.R.S. 89.250 applies to a Commission Form of Government and not to a "City Manager Form of Government" (K.R.S. 89.390 to 89.980 inclusive) and,

WHEREAS it appears that the petition does not meet many of the requirements provided by law applicable to a City Manager Form of Government with respect to Referendum or initiative, and,

WHEREAS it is obvious on the face of the petition that a substantial number of the signatures thereon are questionable and that a complete and accurate check of these signatures would require more time and expense than is justified under the circumstances,

NOW THEREFORE, it is ordered that said petition be denied and that a copy of this resolution be sent to Mr. John Ward.

Ed Venters moved that the resolution be adopted as read. Bruce Walters seconded the motion. The vote was as follows:
