Minutes of Special Meeting of the Board of Commissioners of the City of Pikeville, Kentucky, held on September 24, 1963, at City Hall, pursuant to notice hereto attached, for the purpose stated, i.e., to consider bids and award contracts for construction of Sewer System improvement under contracts four (4) and five (5), as advertised. At which all commissioners were present with W. E. Butcher, City Manager, and O. T. Hinton, City Attorney, and Robert P. Johnson of Watkins and Associates, Inc., in attendance.

E. Bruce Walters acting as Mayor Pro-Tem.

B. P. Bogardus offered the following resolution, and moved its adoption, which motion was seconded by W. E. Venters.

'WHEREAS, Watkins and Associates, Inc., Consulting Engineers, have considered all bids received for the construction of Sanitary Sewer System Improvements, Contract V, for the City of Pikeville, Kentucky, and have duly made their recommendations to this Board of Commissioners, and it is appearing from said recommendations that Acton Construction Co., Inc., St. Paul, Minnesota, is the lowest and best responsible bidder for the said improvements in the sum of One Hundred Fifty-Six Thousand Three Hundred Fifty-Seven and 50/100 Dollars (
(\$156,357.50), and that said Contractor has offered by accompanying letter a deduction in the sum of Eleven Thousand Six Hundred Seventy-One Dollars (\$11,671.00) provided that limestone from Johnson Brothers, Elkhorn City, be accepted, this resulting in a total sum of One Hundred Korty-Four Thousand Six Hundred Eighty Six and 50/100 Dollars (\$144,686.50), and that this Board of Commissioners, after considering said recommendations, find that the bid of Acton Construction Co., Inc., St. Paul, Minnesota, is the lowest and best bid.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the City of Pikeville, Kentucky, as follows:

Section 1: That the bid of Acton Construction Co., Inc., St. Paul, Minnesota, in the negotiated sum of One Hundred Forty-Four Thousand Six Hundred Eighty-Six and 50/100 Dollars (\$144,686.50) is hereby accepted, and that a contract for the construction of said work, as heretofore prescribed by the approved plans, specifications and contract documents shall forthwith be executed for said construction.

Section 2: That the Mayor is hereby authorized and directed to execute said contract for and on behalf of the City of Pikeville, Kentucky, upon approval of said contract by the Housing and Home Finance Agency, the completion of the necessary financial arrangements, and further approval by the Engineers of the said Elkhorn City source of filter stone.

Minutes of Special Meeting of the Board of Commissioners of the City of Pikeville, Kentucky, held on October 1, 1963, the Mayor and all Commissioners present and participating and W. E. Butcher, City Manger and O. T. Hinton, City Attorney, in attendance.

Mr. Ken Ratliff of R. L. Persinger and Co., was present and reported that he had nothing definite to report with respect to personnel, compensation and equipment required to put his former recommendations into effect pursuant to the resolution of the Board passed at its meeting held on September 24, 1963, and that he would continue to give this his personal attention on an hourly basis and estimated that his charge would not exceed Two-Hundred Fifty (\$250.00) Dollars per month.

W. E.
