Dear Mr. Butcher:

Pursuant to the meeting held with you and Mr. Hinton in our Lexington office on the afternnon of January 29, transmitted herewith are the original and two copies of Supplemental Agreement No. 1 to the Agreement of October 1, 1962 between City of Pikeville, Ky. and Watkins and Associates, Inc.

The purpose of Supplemental Agreement No. 1 is to modify the provisions of the original agreement to recognize the completion of preliminary engineering services in connection with the water and sewer systems and to retain preliminary engineering services in connection with the gas systems (including the appraisal of the Consumers Gas Company and the Shale Gas Company properties) without increase in the total compensation of \$9000 as provided in the original agreement.

With respect to the \$9000 total fee for preliminary services, \$5000 has previously been paid for such services in connection with the water and sewer systems; the remaining \$4000 becomes payable upon completion of our preliminary engineering services in connection with the gas systems.

SUPPLEMENTAL AGREEMENT No. 1
TO THE
AGREEMENT OF OCTOBER 1, 1962
BETWEEN

CITY OF PIKEVILLE, KENTUCKY, AND WATKINS AND ASSOCIATES, INC.

THIS SUPPLEMENTAL AGREEMENT NO. 1 made and entered into at Pikeville,

Pike County, Kentucky, this _______, l964 by and between
the City of Pikeville, Kentucky hereinafter called the CITY, and Watkins and
Associates, Inc. Consulting engineers, Lexington, Ky. hereinafter call ed Engineer,

WITNESSETH:

THAT WHEREAS, the Agreement of October 1, 1962, includes specific provisions pertaining to preliminary services in connection with the sewer, water and gas systems as set forth in the Agreement under "2". Services to be Performed by the ENGINEER under this agreement (a) Study and Report" and "3. Compensation to be paid to the ENGINEER under this Agreement (a) Study Reports," and

WHEREAS, the intent of these provisions has been accomplished by the ENGINEER insofar as they apply to the sewer and water programs, and payment therefor in the amount of Five Thousand (\$5000.00) Dollars as provided therein has been made by the CITY TO the ENGINEER under Invoice No. 1, dated February 28, 1963 (Watkins and Associates Job. No. 1535), and

WHEREAS, further studies and/ or reports for the current sewer and water programs are not required, and

WHEREAS, the scope of engineering services pertinent to a study and report for the natural gas system has been increased through the appraisal of the Consumers Gas Company and Shale Gas Company properties and assistance to the City in the acquisition of these properties,

NOW, THEREFORE, in consideration of these premises and the mutual covenants set forth herein, it is agreed by and between the CITY and the ENGINEER as follows, to wit:

1. Agreement of October 1, 1962.

All provisions of the Agreement of October 1, 1962, shall remain in full force and effect except as modified hereinafter.

- 2. Services to be performed by the ENGINEER
 - (a) It is mutally agreed that the services of the ENGINEER with respect to Paragraph 2 (a), (1),(2) and (3) pertaining to the current sewer and water system programs have been completed.

Paragraph 2 (a) (4) pertaining to the municipally-owned gas system is retained but expanded to include the appraisal of the privately-owned Consumers and Shale Gas Company systems and services incidental to the acquisition thereof by the CIYY,

The only remaining studies and reports reguired shall be those relating to the gas systems.

(b) Design and Inspection of Construction

The provisions of this section, Paragraph 2 (b) of the Agreement of October 1, 1962, have been accomplished with respect to the sewer and water systems but remain in effect for the gas system.

3. Compensation to be Paid to the ENGINEER

(a) Study and Report

With respect to the services set forth under Paragraph 2 (a) hereinbefore, the ENGINEER acknowledges receipt of payment from the CITY of the sum of Five Thousand (\$5000.00) Dollars for the completion of all services specified in connection with the sewer and water system programs.

As compensation for services in connection with the gas system program as set forth herein under Paragraph 2(a) (4), the CITY agrees to pay the ENGINEER the additional sum of Four Thousand (\$4000.00)) Dollars upon completion of these services.

The compensation of Five Thousand (\$5000.00) Dollars and of Four Thousand (\$4000.00) Dollars or a total of Nine Thousand (\$9000.00) Dollars as set forth immediately above is in the same total amount but in lieu of the Nine Thousand (\$9000.00) Dollars set forth in Paragraph 3 (a) of the Agreement of October 1, 1962.

(b) Design and Inspection of Construction

The provisions of this section, Paragraph 3 (b) of the Agreement of October 1, 1962, have been accomplished with respect to the sewer and water systems but remain in effect for the gas system.
