The following Resolution was offered by Mr. W. E. Butcher, City Manager:

RESOLUTION

RESOLVED that after entended discussion and consideration, it has been deemed advisable and to the best interest of the City to agree to furnish the Mayo Village Water system water under terms and conditions set forth in a contract prepared by O. T. Hinton, City Attorney, which contract has been presented, read and considered and is attached to and made a part of this Resolution.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and City Clerk be and they are hereby authorized and directed to enter into said contract and execute the same for and on behalf of the City of Pikeville.

The contract in question is copied and made a part of this Resolution and is as follows:

CONTRACT

This CONTRACT, made and entered into this 19th. day of November 1964, by and between the City of Pikeville, Kentucky, a municipal corporation hereinafter called THE CITY, and MAYO VILLAGE WATER WORKS, INC., a corporation of Pike County, Kentucky, hereinafter called WATER COMPANY.

WITNESSETH:

WHEREAS, the WATER COMPANY is the owner of and operates a water system as a public utility company, supplying water service

to residents and businesses in the area extending from a point about .7 miles south of the City Limits of Pikeville on U. S. 23 to a point about 2.5 Miles south of the City Limits on U. S. 23, and desires to purchase water at a wholesale rate to supply its customers connected with its water system and is now using about 1,200,000 gallons per month for that purpose, and

WHEREAS, THE CITY is the owner and operator of a modern water supply system which manufactures water for public service use which has a capacity of about 1,500,000 gallons per day and is now using on an average of about 500,000 gallons per day and can produce any excess above its requirements and within its capacity at a comparatively low cost,

NOW, THEREFORE, in consideration of the premises, it is mutually agreed between the parties that THE CITY will furnish the WATER COMPANY at a connection to be made at the southern limits of the City on U. S. 23 filtered water of the kind and quality used in its system in such quantities as may be needed to supply the WATER COMPANY system upon the following terms and conditions:

PRICE. The price shall be 25¢ per 1,000 gallons measured at a standard meter to be furnished, installed and maintained by THE CITY at the point of intake payable monthly on the 20th day of the month for all water used during the preceding calendar month according to meter readings taken on the last day of each calendar month.

MINIMUM. The WATER COMPANY will guarantee to use or pay for at least 1,000,000 gallons each month regardless of how much may be actually used, during the existence of this contract.

TERM. This contract shall begin as soon as THE CITY has extended its water mains to the southern City Limits with a main line of at least four inches (4") in diameter, at prevailing pressure at that point; said main to be extended and made available to the WATER COMPANY as soon as the work of extending the main from the present southern terminus on U. S. 23 can be reasonably done. This contract shall extend from the time of connection at the terminus as above defined, for a period of one (1) year, with the privilege of extending the contract upon the same terms and conditions as herein stated from year to year and shall continue in force automatically unless terminated by either party by written notice at least one (1) year prior to the effective date of termination.

RENEGOTIATION. The parties recognize that prevailing cost of producing the water supply covered by this contract and the services required to produce the same may vary from time to time and it is therefore agreed that the price for which the water shall be furnished under this contract may be renegotiated at any time upon the request of either party by giving notice at least thirty (30) days in advance of the date of renegotiation and that said renegotiation shall proceed upon a basis of changed conditions affecting cost of producing and servicing the water supply covered by this contract, and the basic charge herein provided of 25¢ per thousand gallons.

MAXUMUM. It is understood that THE CITY shall not be required to furnish water during any period beyond the capacity of its then existing plant and that the amount to be furnished under this contract is purely and strictly within the limits of the excess capacity of its plant at any given time over and above the requirements needed to serve the citizens and other customers served by its water system and that under no circumstances will THE CITY be obliged to furnish any quantity of water to the WATER COMPANY under this contract in excess of those limits.

FIRE HYDRANTS. it is understood that the WATER COMPANY does not intend to install fire hydrants on its system at this time and the CITY will not be required to furnish water or water pressure for any fire hydrants under this contract.

CANCELLATION. THE CITY shall have the right to cancel this contract at any time that the WATER COMPANY fails to pay any monthly bill within ten (10) days after the same becomes due and may do so by giving notice by mail addressed to the WATER COMPANY at Pikeville, Kentucky, of its intention to do so, which notice shall be given at least twenty-four (24) hours before disconnecting the water supply.
