

# MINUTES } CITY OF PIKEVILLE

At a regular meeting of the Board of Commissioners of the City of Pikeville, Kentucky, held in Starlite on March 5, 1965 at 7:30 P. M. the following Members of the Board were present.

Also present were City Manager, W. E. Butcher and City Attorney, O. T. Hinton.

John S. Petot, Jr. C. P. A. presented the audit report for the fiscal year ended June 30, 1964.

The Mayor directed the City Manager, City Attorney and City Clerk to meet with John Petot to discuss the matter of publishing the audit report that had been prepared by Mr. Petot.

The following bids were received due to a published advertisement:

Mr. Butcher presented the following bidson a posting machine for the Utility Department.

Mr. Butcher stated that the Burroughs machine was in accordance with the advertised specifications and was therefore more suited to the city utility billing consequently he recommended the Burroughs machine.
