

MINUTES } CITY OF PIKEVILLE

At a regular meeting of the board of commissioners of the City of Pikeville, Kentucky Held in the Starlite Bowling Center on March 19, 1965 at 7:30 P. M. the following members of the board were present.

The Mayor advised that he had received a request from Housing and Home Finance Agency for a resolution conforming to the Civil Rights Act of 1964 in connection with the water and sewer project known as Project No. APW-Ky.-5G. The Mayor submitted and read the following resolution prepared by the City Attorney:

RESOLUTION

Whereas, the city of Pikeville has applied and been granted certain aid by the Federal Housing and Home Finance Agency in connection with it's water and sewer project known as Project No. APW-Ky.-5G, and

Whereas, by act of Congress known as the Civil Rights Act of 1964, (42 U.S.C.A. 2000d-1), the Federal Housing and Home Finance Agency has promulgated Part 1 of the Subtitle A of Title 24 known as the nondiscrimination provision which provides in substance that no person in the United States shall, on the ground of race, color or national origin, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity receiving Federal financial assistance from the Housing and Home Finance Agency, and

Whereas, the City of Pikeville has received Federal financial assistance from the Housing and Home Finance Agency in connection with the above mentioned project,

Now, therefore, be it resolved by the Board of Commissioners of the City of Pikeville that the United States of America and the Housing and Home Finance Administrator be, and they are hereby assured by the Board of Commissioners of the City of Pikeville of full compliance with the rules and regulations of the Housing and Home Finance Agency effectuation Title VI of the Civil Rights Act of 1964, which act is hereby adopted by reference as a part of this Resolution.

Be it further resolved that a copy of this Resolution be certified by the City Clerk and forwarded to the Housing and Home Finance Agency, Office of the Regional Administrator, at 645 Peachtree-Seventh Building, Atlanta, Georgia.

Commissioner F. W. Baker moved the adoption of the above Resolution. Commissioner Kermit Sexton seconded the motion. Upon roll call the vote upon this motion was as follows:
