WHEREAS, the matter of which bid is most advantageous to the City of Pikeville, Kentucky, has been sufficiently considered.

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF PIKEVILLE, KENTUCKY, DOES

HEREBY RÉSOLVE AS FÓLLOWS:

l. That the bid of F. L. Dupree & Co. Inc., Merrill Lynch, Pierce Fenner & Smith, Inc., Hayden, Stone, Inc., Seasongood & Mayer, Walter, Woody & Heimerdinger for the sale of said \$815,000 of City of Pikeville School Building Revenue Bonds, dated June 1, 1965, be accepted and confirmed, the said bid being at the price of \$815,000 for \$815,000 principal amount of bonds, plus accrued interest from June 1, 1965, to bear interest at the rates of 6% 1967to 1970inclusive; 3 3/4% 1971 to 1977 inclusive; 4% 1978 to 1986 inclusive; 4 1/8 % 1987 to 1991 inclusive; 4.20 % 1992 to 1996 inclusive. and the said bid being hereby determined to be the highest and best bid to the City for said bonds, and the interest rates on said bonds are fixed by resolution of the Board as set out in said successful bid.

2. That said bonds numbered 1 through 815 shall be delivered by the City Treasurer and/or other proper City officials to said purchaser as soon as ready, in accordance with the ordinance authorizing such bonds, and the proceeds of all of said bonds, shall be used only as provided in said ordinance.

3. That the confirmation of this bid subjects the City to no liability if for any reason it is unable to obtain the final approving legal opinion of Skaggs and Hays, Attorneys, Louisville, Kentucky, or if said bonds or the interest thereon should be subject to ad valorem or income taxation by the Federal government, Kentucky, or any political subdivision of Kentucky prior to the delivery of said bonds without the final approving opinion of said attorneys accompanying said bonds or if such bonds or the interest thereon should become so subject to taxation.

4. That all motions, resolutions or ordinances of parts thereof in conflict herewith be and the same are hereby repealed to the extent of such conflict.

RESOLUTION

WHEREAS, a majority of the residents and property owners of the territory known as "Pauley Addition" situated in the northern portion of the City Limits of the City of Pikeville, have requested that the streets of said Pauley Addition including the road extending from the Big Dandy Bridge along the southern edge

of the addition, be improved by blacktop surfacing and ditching, and
WHEREAS, it appears that there is already an eighteen foot compacted stone
base on said streets and that the residents and property owners are willing to
have such improvement made at the exclusive cost of the owners of the property
benefited as defined by K. R. S. 94.301, such cost being estimate at approximately
\$5.00 per foot of property abutting on the streets to be improved within said
Pauley Addition and that said improvements can be made under the provisions of K.

NOW, THEREFORE, BE IT RESOLVED that the improvements mentioned above are hereby declared to be a necessity in accordance with the provisions of K. R. S.

R. S. 94.292 as a "stage" improvement as defined by K. R. S. 94.292 and without

94.292 (2).

BE IT FURTHER RESOLVED that this Resolution shall be published in the next issue of the Pike County News in compliance with the provisions of K. R. S. 94.292 (2) and that the City Attorney shall prepare an ordinance to be considered for passage at the expiration of thirty days after the publication of this resolution, complying with all of the provisions of K. R. S. 94.290 to 94.325, and the provisions of this Resolution.

The following Resolution was offered and read in its entirety.

RESOLUTION

It appearing that the City of Pikeville and Pike County have heretofore agreed to organize and maintain a joint Civil Defense organization under the provisions of Chapter 39 of the Kentucky Revised Statutes and particularly K. R. S. 39.415 and have appointed a joint director in accordance with the provisions of K. R. S. 39.415 functioning within the territorial limits of the County and it further appearing that the City of Pikeville has received no cooperation from Pike County or any of its officials in the organization or maintenance of the Civil Defense establishment of the equipment necessary to maintain and operate the same and it further appearing that it would be advantageous and advisable for the City of Pikeville to establish and maintain a separate

Civil Defense organization. NOW THEREFORE, BE IT RESOLVED that the City of Pikeville withdraw from any joint undertaking with Pike County for the establishment and operation of a Civil Defense organization under the statute above mentioned and establish a separate Civil Defense organization which shall be maintained solely by and through the officials and resources of the City of Pikeville with power to function anywhere within the City Limits of the City of Pikeville or within the boundary of Pike County, all in accordance with the provisions of Chapter 39 of the Kentucky Revised Statutes and with particular reference to K. R. S. 39.415, 39.416 and

39.417. BE IT FURTHER RESOLVED that the City Attorney, O. T. Hinton, be authorized and directed to take such steps as may be necessary to effectually dissassociate the City from any joint organization or arrangement heretofore made with Pike County and to establish and set up a separate Civil Defense organization for the

City of Pikeville alone. BE IT FURTHER RESOLVED that the Mayor shall appoint W. E. Butcher as director of the Civil Defense organization for the City of Pikeville under the provisions of K. R. S. 39.415 with each and all of the powers and authorities prescribed by Chapter 39 of the Kentucky Revised Statutes applicable thereto. Commissioner Kermit Sexton moved the adoption of the foregoing Resolution.

Harry Hobson, Commissioner, seconded the motion. Upon roll call, the vote was as follows:
