At a special meetin of the Board of Commissioners of the City of Pikeville Kentucky, held in the City Hall on March 28, 1966 at 7:30 p.m. The following were present:

The Mayor called the meeting to order and announced that the purpose of the meeting was stated in the meetin notice as follows:

Notice is hereby given that a special meeting of the Board of Commissioners of The City of Pikeville has been called by the Mayor and will be held on Monday March 28, 1966, at 7:30 p.m. at The City Hall for the following purposes:

- (1) To consider a resolution authorizing the Mayor to file preliminary inquiry concerning Federal assistance for water and sewer projects and waste treatment plants in connection with the proposed water and sewer extensions to serve annexed territory, and territory to be annexed on Fergusion Creek and on Lower Chloe Creek, and in connection with the porposed Coal Run water system, and to do such other things as may be necessary and incident thereto.
- (2) To consider a resolution authorizing the Mayor and the Clerk to execute and deliver to the Commonwealth of Kentucky for the use and benefit of the Department of Highways a certain strip of ground extending from the intersection of U.S. 23 with the road up Lower Chloe Creek to The Pikeville City School Property, and to do all other things necessary and incident thereto.
- (3) To consider such other business as may come before the Board.

Mr. Walter May and Mr. Robinson having appeared before the Board with a design for three (3) signs to be erected at the three (3) entrances to the City advertising the fact that the City of Pikeville had been designated as an "All American City" and requested that the City pay for the maintenance of these

signs at the rate of one Dollar (1.00) per day per sign for a period of one (1) year and the members of The Board having considered and discussed the matter and the City Attorney having expressed the opinion that this Board should not obligate the City for expenditures beyond the present fixed aperiod and that the proposed payment for maintenance of these signs for a period of one (1) year would be a legal expenditure from the general funds of the City for public and beneficial purposes within the budget for the present fiscal period, the following resolution was presented.

Resolved that the 'ity Manager and City Clerk be authorized and directed to pay the May Company, the sum of \$1095.00 to cover the expense of installing and maintaining for one (1) year, three (3) signs at the entrances to the City on the three (3) main highways leading into the City, in accordance with the designs approved by The Pike County Chamber of Commerce, when said signs have been erected and approved by the said Chamber of Commerce, at the rate of One Dollar (\$1.00) per day per sign for a period of One (1) year.

RESOLUTION

W.E. Butcher, City Manager, presented the following resolution:

WHEREAS, it appears that the Department of Highways of the State of Kentucky requires a strip of ground extending from the right-of-way line of U.S. highway 23, along the existing road up Chloe Creek to the line of the property conveyed by the City to the Pikeville City School District for a distance of about 362 feet, varying in width from about 25 feet to 45 feet, and

WHEREAS, the engineers for the Department of Highways have submitted a deed conveying said strip, which has been revised and approved by 0. T. Hinton, CityAAttorney, and

WHEREAS, it appears necessary and advantageous for the City to convey said strip to the Department of Highways for highway purposes in constructing a new road way serving the Pikeville City School District facilities.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and City Clerk are hereby authorized and directed to execute the above mentioned deed by delivering the same to W.E. Butcher, City Manager, for delivery to the Department of highways of the State of Kentucky.

RESOLUTION

The following resolution was presented by the City Manager, Mr. W. E. Butcher:

WHEREAS, Mr. Grant of the engineering firm of Watkins and Associates, of Lexington, has presented a "preliminaryyinquiry" concerning Federal assistance for water projects, sewer projects, and waste treatment plants, prepared on Government Form #101 prescribed by the Federal Bureau of the Budget, and covering proposed water and sewer system extensions up Ferguson Creek and Chloe Creek and extensions to supply Goal Run water system, and

WHEREAS, it appears possible to the City to obtain Federal aid in connection with these sewer extensions and projects, and

Whereas, the City Manager has recommedned that this "preliminary inquiry" be executed and filed.

I have received a notice from the Governor requesting attendance by myself as City Attorney and the Chief of Police and the City Police Judge at a conference to be held by Mr. Charles B. Jones Coordinator of the Governor's Coordinating 1966, Committee for TrafficeSafety at Frankfort, Kentucky, on Wednesday, April 13, 1966, at 9:00 a.m.
