

## MINUTES } CITY OF PIKEVILLE

At a regular meeting of the Board of Commissioners of the City of Pikeville, Kentucky held in City Hall on August 1, 1966 at 7:30 p.m. the following were present:

The following order was presented to the Board and read by the Mayor.

It appearing that by Ordinance adopted August 9, 1954, appearing in Civil Ordinance Book 1, Page 441, a joint City-County Airport Board was approved and ordained pursuant to the provisions of what was then K.R.S. 183.370 and it further appearing that two vacancies exist in the members of the board from the City of Pikeville, and one vacancy from the County of Pike, occasioned by the resignations of Dr. Russell Davis, Z. Charles Justice from the appointees from the City and Charles R. Chrisman from the appointees from the County, which vacancies are to be filled by the joint appointment to the County Judge and the Mayor, under provisions of K.R. S. 183.132 (3)-(C), being Section 5 of Chapter 134 of the Acts of 1964 which became effective June 18th, 1964, and it further appearing that the County Judge of Pike County has entered an order on July 22nd, 1966 appointing and approving the appointments of members shown below,

NOW THEREFORE, in order to bring membership of the Board to its full quota of six (6) members each to serve for a period of four (4) years, it is now ordered that the members of the Board and the terms of their respective offices for both Pike County and the City of Pikeville are as follows:

Members of the Board from the City of Pikeville and their terms of office are as follows:

- (1) W. E. May is appointed to fill the unexpired term of Dr. Russell Davis which extends for a period of four (4) years from September 1st, 1965.
- (2) F. W. Baker is appointed to fill the unexpired term of Z. Charles Justice which extends for a period of four (4) years from September 1st, 1962.
- (3) The other current member of the Board from the City is Frank Forsyth whose term extends four (4) years from September 1st, 1964.

The Members of the Board from the County are as follows:

- (1) Joan Roberts is appointed to fill the unexpired term of Charles R. Chrisman which extends for a period of four (4) years from September 1st, 1965.
- (2) D.R. Batten, whose term extends for a period of four (4) years from September 1st, 1962.
- (3) Noah Howard, whose term extends for a period of four (4) years from September 1st, 1964.

Upon expiration of the respective terms of these members, their successors shall be appointed for a period of four (4) years in the manner provided by the aforesaid section of the Kentucky Revised Statutes.

The above appointments made jointly by the Mayor of the City of Pikeville and the County Judge of Pike County, as above noted, are now officially approved pursuant to the Statute mentioned and ordered entered upon the Minute Book of the meetings of this Board.
