## MINUTES OF A REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF THE CITY OF PIKEVILLE HELD AT CITY HALL ON JANUARY 1, 1968 AT 9:00 A.M.

Upon roll call, those in attendance were as follows:

The Mayor announced that the first order of business would be the swearing in of new commissioners. Thereupon came Orville Clark, Harry Hobson, Warren Keene and Kermit Sexton, each of whom took the oath of office prescribed by Section 128 of the Constitution of the State of Kentucky administered by the Honorable Buford Johnson, Judge of the Pikeville Police Court.

The Mayor announced that W.E. Butcher, City Manager, was called out of town on account of the death of his sister and offered the following Resolution.

### RESOLUTION

IT APPEARING that the City Manager, W.E. Butcher, is absent because of a death in his family and that the City Manager has made no recommendation as to employees or other personnel for the current year pursuant to K.R.S. 89.570 except his recommendations for the present personnel heretofore made, now in order to provide the uninterrupted operation of the City Government, be it resolved that all non-elected personnel now serving the City of Pikeville in any and all departments and capacities, including the City Manager, be continued in office at their present salaries for a period of sixty (60) days from and after this date, to-wit: until the end of February 29, 1968.

Commissioner Warren Keene moved the adoption of this Resolution. Commissioner Kermit Sexton seconded the motion. Upon roll call, the vote was as follows:

The Mayor declared the Resolution adopted and it is accordingly ordered that all present personnel be continued in their respective positions and offices until the end of February 29, 1968 at their present salaries.

The Mayor announced that the next order of business would be the selection of a Mayor Pro Tem.

Commissioner Orville Clark nominated Warren Keene as Mayor Pro Tem. Commissioner Harry Hobson seconded the nomination. There being no further nominations, the roll call upon this nomination was as follows:

The Mayor announced that Commissioner Warren Keene had been and would be the Mayor Pro Tem of this commission until his successor was duly selected and qualified.

The Mayor announced that the time and place for regular meetings of the Commission should be fixed.

Commissioner Orville Clark moved that the regular meetings of the Board of Commissioners be fixed for the first and third Fridays of each month at 7:30 P.M. at the City Hall. Commissioner Harry Hobson seconded the motion. Upon roll call, the vote was as follows:

The Mayor declared the motion carried and the regular meetings fixed as stated in the motion.

The Mayor announced that there was a vacancy in the Municipal Housing Commission caused by the resignation of Walter P. Walters, one of the two Democrats who had been nominated to serve on this board, which the law required to consist of two members from the Democratic party and two members from the Republican parts.

The Mayor announced that he had appointed Margaret Hatcher, a registered Democrat, to fill this vacancy and asked that this appointment be approved.

Commissioner Kermit Sexton moved that the appointment of Margaret Hatcher to fill the vacancy upon the Pikeville Municipal Housing Commission be approved and confirmed. Commissioner Warren Keene seconded the motion. Upon roll call, the vote was as follows:
