RESOLUTION OF COMMISSIONERS FOR THE CITY OF PIKEVILLE, KENTUCKY, APPROVING REQUEST FOR FINANCIAL ASSISTANCE TO PLAN AND DEVELOP A COMPREHENSIVE CITY DEMONSTRATION PROGRAM AND AUTHORIZING EXECUTION OF CONTRACT THEREFOR AND EXECUTION AND FILING OF REQUEST FOR SUCH FUNDS.

WHEREAS the City of Pikeville, Kentucky, desires to undertake a comprehensive city demonstration program to rebuild or revitalize large slum and blighted areas and generally improve living conditions for the people who live in such areas:

WHEREAS the Secretary of Housing and Urban Development (hereafter REFERRED TO AS THE "Secretary") is authorized pursuant to Title I of the Demonstration Cities and Metropolitan Development Act of 1966 to make grants to and contract with, City Demonstration Agencies to pay up to 80 percent of the costs of planning and developing such comprehensive city demonstration programs and

WHEREAS the Secretary has tendered a contract under which the United States of America (herein called the "Government") agrees to make a grant to pay a portion of the costs of planning and developing of a comprehensive city demonstration program.

NOW, THEREFORE, be it resolved by the commissioners of City of Pikeville, Kentucky as follows:

Section I. Approval is hereby granted (1) for the submission by the City of Pikeville, Kentucky of a request for financial assistance for the planning and development of a comprehensive city demonstration program; (2) for the provision of any information or documentation concerning the preparation and content of such program as may be required by the Secretary; and (3) for the representation by William C. Hambley, Mayor, or his lawful successor, as the authorized representative empowered to act on behalf of City of Pikeville in connection with all matters pertaining to the request for financial assistance.

Section 2. The City of Pikeville, Kentucky hereby agrees to comply with the regulations of the Secretary effectuating Title VI of the Civil Rights Act of 1964, which provide that no person shall, on the ground of race, color or national origin, be excluded from participation in be denied the benefits of, or be subjected to discrimination in the undertaking of any of the projects or activities assisted under Title I of the Demonstration and Metropolitan Development Act of 1966.
