Resolution authorizing filing of application with the Department of Housing and Urban Development, United States of America, for a loan under the terms of Public Law 345, 84th Congress, approved August 11, 1955, as amended.

WHEREAS, under the terms of said Public Law 345, the United States of America has authorized the making of loans to public agencies to aid in financing the construction of specific public projects:

Now, Therefore, be it resolved by Board of Commissioners,

- 1. That William C. Hambley, Mayor, City of Pikeville, Kentucky be and he is hereby authorized to execute and file an application on behalf of City of Pikeville, Kentucky with the Department of Housing and Urban Development, United States Government, for a loan to aid in financing the construction of Pikeville Public Hospital.
- 2. That said Mayor be and he is hereby authorized to execute and file an assurance of compliance with Title VI of the Civil Rights Act of 1964 on behalf of City of Pikeville, Kentucky with the Department of Housing and Urban Development, United States Government, in support of the aforementioned application.
- 3. That William C. Hambley, Mayor be and he is hereby authorized and directed to furnish such information as the Department of Housing and Urban Development may reasonably request in connection with the application which is herein authorized to be filed.
