RESOLUTION AUTHORIZING SUBMISSION OF PARTS II AND III OF
COMPREHENSIVE DEMONSTRATION PROGRAM TO SECRETARY OF HOUSING
AND URBAN DEVELOPMENT

WHEREAS, the City of Pikeville, Kentucky has heretofore prepared and submitted a Comprehensive City Demonstration Program, Part I

WHEREAS, Parts II and III with the contained budget therein, have been approved by the commission for community services of the City of Pikeville on May 2, 1969,

WHEREAS, the Board of Commissioners desires that the Comprehensive City Demonstration Program Parts II and III be submitted to the Secretary of Housing and Urban Development (hereinafter referred to as Secretary) for funding under Title I of the Demonstration Cities and Metropolitan Development Act of 1966,

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the City of Pikeville, Kentucky that Parts II and III of said program be and they are hereby approved and the Mayor or his successor is authorized to submit to the Secretary Parts II and III with the contained budget therein, of the Comprehensive City Demonstration Program and such supporting and collateral material that may be necessary.
