The Mayor stated that the Model City Staff needed to be retained and continued in their employment with the Model City Agency, together with the need of additional staff members; that the additional positions had been approved by the Atlanta Regional Office and that all of these staff members would be paid out of the funds received by the Model City Program from the Federal Government and the Mayor requested that the following employees be retained and continue in their employment with the Model City Agency with the salaries noted:

The Mayor declared the motion adopted.

The Mayor presented Mr Lawton Allen of the firm of Helton & Linton Accountants of Pikeville, Kentucky, who explained the procedures of making an audit of the financial condition of the City and an inventory of the property of the City and the requirements therefor. Mr Allen stated that the cost for such an audit and inventory would not exceed the sum of \$5,000.00, and with proper cooperation of the city officials, the costs would range between \$3,000.00 and \$5,000.00.

Commissioner Kermit Sexton moved that Helton & Linton Accountants be engaged to make a complete audit and inventory of the City's financial condition and the City property covering the 1968-69 fiscal year at a cost not to exceed \$5,000.00 and to be completed by August 11, 1969.

Commissioner Kermit Sexton moved that such funds that are necessary to operate the Model City Agency pending receipt of funds from the regional office of HUD from Federal Government for the operation of said agency on a monthly basis not exceed the sum of \$10,943.33 per month or a total of \$32,830 for three months, all beginning July 1, 1969, And further that Ray Burke, City Treasurer, and Charles L. L. Huffman, City Clerk, are authorized to excute any and all promissory notes on behalf of the City of Pikeville for the Model City Agency borrowing such funds as needed.
