The Mayor presented and read an Ordinance known by its title as "AN ORDINANCE AUTHORIZING THE CONSTRUCTION OF AN EXTENSION OF THE WATER SYSTEM IN THE RATLIFF CREEK, HAROLD BRANCH, FERGUSON CREEK, LOWER CHLOE CREEK AND THE FAIRVIEW AREAS AND THE CONSTRUCTION OF AN EXTENSION OF THE SEWER SYSTEM IN THE FERGUSON CREEK LOWER CHLOE CREEK AND THE FAIRVIEW AREAS WITHIN THE CITY OF PIKEVILLE, KENTUCKY AND ADJACENT THERETO; PROVIDING FOR THE ACQUISITION OF RIGHT OF WAYS AND EASEMENTS; AND PROVIDING FOR EXPENDITURE AND REIMBURSEMENT OF FUNDS; AND TO ADVERTISE FOR BIDS.
