The meeting began with the following report from the City Manager who stated he had visited the Model Cities Activity Center and that the conditions were deplorable, and he stated that he had not received any authorization from Atlanta to release any money for the Activity Center, Mr. Hall recommended that the center be closed until something is settled.

Mayor Hambley stated that he had a letter from Metzger, authorizing the employment of a fiscal officer for this project.

A petition was presented to the Commission which consisted of 56 citizens concerned about the closing of the Activity Center, they were asking for continuance of the Center at its present or increased level of operation, commission directed the recreation Director and the City Manager to work out a program suitable for the Activity center.

Mr. Paul McDonald from the Pauley Addition asking for speed bumps to be constructed in this area, due to some incidents of speeding and reckless driving, Mr. McDonald presented a petition to the Mayor with 42 signatures requesting that these speed bumps be installed. City Manager was directed to erect three 3 speed bumps in the Pauley addition.
