The first item of business was a withdrawal of **AN ORDINANCE PROVIDING FOR TAXICAB OPEN STAND PARKING; LIMITING PARKING BY TAXICABS; PROVIDING MONTHLY PARKING FEE IN LIEU OF METER CHARGE; PROVIDING SEVERABILITY; AND PROVIDING PENALTIES AND THE RIGHT TO IMPOUND AND TOW ILLEGALLY PARKED VEHICLES:** Said Ordinance had not been presented before the Commission; therefore, no vote was required to withdraw the same.

Mayor Hambley stated that Ordinance No. 72-7-0 entitled **AN ORDINANCE AUTHORIZING THE ANNEXING OF PROPERTY PRESENTLY KNOWN AS POOR FARM PROPERTY AND INCLUSIVE OF AN AREA LYING TO THE NORTH OF THE POOR FARM PROPERTY AND REPEALING ORDINANCE DATED DECEMBER 6, 1971,** had been declared illegal due to the fact that the boundary lines were wrong. WHEREAS, the Comprehensive City Demonstration Program (herein referred to as "Comprehensive Program") for the model neighborhood of the City of Pikeville was approved by Resolution adopted by the Board of Commissioners of the City on December 15, 1969, and

WHEREAS, a Grant Agreement with the United States of America was executed on December 15, 1969 providing for Federal financial assistance under Title I of the Demonstration Cities and Metropolitan Act of 1966, and

WHEREAS, the Second Year Action Program amending the Comprehensive Program was approved by Resolution adopted on February 12, 1971 by this City, and

WHEREAS, the Secretary of Housing and Urban Development (hereinafter called "Secretary") has approved a proposed Third Year Action Program and has tendered a revised grant budget providing for an additional grant under said program, and

WHEREAS, copies of said Third Year Action Program and said Revised Grant Budget are hereto attached and adopted by reference as a part of this Resolution.

NOW THEREFORE BE IT RESOLVED, by the Board of Commissioners of the City of Pikeville as follows:

## SECTION I

The Third Year Action Program above referred to including the projects and activities described therein and set forth in the Revised

Grant Budget above mentioned which has been approved and tendered by the Secretary, are each hereby approved and the Comprehensive Program above mentioned for the model neighborhood of the City of Pikeville as amended is hereby approved.

## SECTION II

W. C. Hambley, M. D., the duly elected, qualified and acting Mayor of this City is hereby authorized to accept the Revised Grant Budget and to do all things necessary and incident to the implementation and completion of said program.

## SECTION III.

The Board of Commissioners of the City of Pikeville assumes full responsibility for assuring that all grant funds will be used in an economical and efficient manner in carrying out the Comprehensive Program, as amended, and assures the necessary non-Federal share of the cost of Program Administration.

## SECTION IV.

Mayor W. C. Hambley, M. D. is authorized to do all things necessary to carry out the comprehensive Program, including the submission of such reports, certifications and other material as the Secretary shall require and the approval from time to time of revisions in the grant budget, including revisions which increase the total Federal grant and the necessary non-Federal share of the cost of Program Administration providing that any additional required local matching share can be met by contributions of allowable cost items (cash equivalent services, equipment, etc.), which will not necessitate additional cash appropriations.

## SECTION V.

The Fiscal Officer (Burl T. Moore) or his successor or delegate may do all things required to be done in order to obtain payment of the grant, including but not limited to the selection of a commercial bank to receive payment vouchers, the submission of signature specimens, and the filing of requests for payment.

## SECTION VI.

The Mayor, W. C. Hambley, M. D., is further authorized and directed to execute and deliver to the Department of Housing and Urban Development four copies of the required assurance with respect to compliance with Real Property Acquisition Requirements of Title III of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 designated as Appendix 1 A and also four copies of the assurance with respect to Relocation Requirements of Title II of said Act, designated as Appendix 1 B and the Clerk is directed to certify three copies and deliver the same to the Department of Housing and Urban Development and O. T. Hinton, Acting City Attorney, is hereby authorized to certify the same in order to comply with Section 305 of said Act.

RESOLUTION APPROVING SUBMISSION TO THE  
DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT  
AN APPLICATION FOR ACQUISITION OF PROPERTY  
KNOWN AS THE INITIAL ROCK AREA CONTAINING  
APPROXIMATELY THIRTY-FIVE (35) ACRES OF LAND.

WHEREAS, Title VII of the Housing Act of 1961, as amended, provides for the making of grants by the Secretary of Housing and Urban Development to States and local public bodies to assist them in the acquisition and development of permanent interests in land for open space uses where such assistance is needed for carrying out a unified or officially coordinated program for the provision and development of open-space land as part of the comprehensive planned development of the urban area; and

WHEREAS, The City of Pikeville (herein sometimes referred to as applicant) desires to acquire land known as Initial Rock Park Area which land is to be held and used for permanent open-space land for active recreation, nature studies, scenic trails, etc.

WHEREAS, Title VI of the Civil Rights Act of 1964, and the regulations of the Department of Housing and Urban Development effectuating that Title, provide that no person shall be discriminated against because of race, color, or national origin in the use of the land acquired and/or developed; and

WHEREAS, It is recognized that the contract for Federal grant will impose certain obligations and responsibilities upon the Applicant and will require among other things (1) assurances that families and individuals displaced as a result of the open-space land project are offered decent, safe and sanitary housing, (2) compliance with Federal labor standards, and (3) compliance with Federal requirements relating to equal employment opportunity; and

WHEREAS, it is estimated that the cost of acquiring said interest (s) will be Fifteen Thousand Dollars (\$15,000.00).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PIKEVILLE.

That an application be made to the Department of Housing and Urban Development for a grant in an amount authorized by Title VII of the Housing Act of 1961, as amended, which amount is presently estimated to be Seven Thousand Five Hundred Dollars (\$7,500.00), and that the applicant will pay the balance of the cost from other funds available to it.

That adequate open-space land for the locality cannot effectively be provided through the use of existing undeveloped or predominantly undeveloped land;

That the Mayor (W. C. Hambley, M. D.) is hereby authorized and directed to execute and to file such application with the Department of Housing and Urban Development, to provide additional information and to furnish such documents as may be required by said Department, to execute such contracts as are required by said Department, and to act as the authorized correspondent of the Applicant;

That the proposed acquisition is in accordance with plans for the allocation of land for open-space uses, and that, should said grant be made, the Applicant will acquire, develop, and retain said land for the use(s) designated in said application and approved by the Department of Housing and Urban Development;

That the UNITED STATES OF AMERICA and the Secretary of Housing and Urban Development be, and they hereby are, assured of full compliance by the Applicant with regulations of the Department of Housing and Urban Development effectuating Title VI of the Civil Rights Act of 1964;

That the UNITED STATES OF AMERICA and the Secretary of Housing and Urban Development be, and they hereby are, assured of full compliance by the applicant with the Federal labor standards imposed under Title VII of the Housing Act of 1961, as amended.

## MINUTES - MEETING OF APRIL 10, 1972

At a regular meeting of the Board of Commissioners of Pikeville, Kentucky, held on April 10, 1972, in City Hall, the following were present:

Also present was City Manager Ayers Shortt.

The meeting was called to order at 8:05 P.M. Mayor Hambley presented a Workable Program for Community Improvement Certificate from the U. S. Department of Housing and Urban Development.

"This certifies that Pikeville, Kentucky, has presented an acceptable workable program for the prevention and elimination of slums and blight under terms of the Housing Act and is hereby qualified during the effective period of this certification to apply for special Federal assistance and support in achieving its community improvement objectives.

This certificate expires March 31, 1974."

This certificate is for two years, but there will be an interim inspection.

Mayor Hambley announced that he will meet with representatives of the three banks on April 11 to discuss financing of grants on the River Diversion Project or the cut through project. The Mayor stated that the City was ready to go into loan and grant as soon as the finances are tied down.

Mayor Hambley also announced that he is planning a trip for April 13, 1972, to go to Washington to meet with HUD, the Appalachian Regional Commission, the Corps of Engineers and other participants to discuss the River Diversion Project. This will be the last meeting before the signing of interagency agreements.

Mayor Hambley presented a letter from Judge Wayne T. Rutherford dated March 30, 1972:

TO: COMMISSIONERS, CITY OF PIKEVILLE  
ATTENTION: MAYOR W. C. HAMBLEY, M. D.

Gentlemen:

I am sure you are aware of the renovation going on at the Pike County Courthouse under City Permit # 89. We are adding to the Courthouse near the Pike County Health Department and getting ready to begin renovation for a Juvenile Annex Center and Prisoner Processing Center. Due to this renovation, we are losing approximately 10 parking spaces. As your Police Department is aware, since we began construction, we have again been faced with a parking stalemate in the area of the Courthouse Square. Duly elected officials of Pike County have not had a parking space. The Sheriff of Pike County has been double parking due to no parking spaces available.

It is respectfully requested that the City give every consideration to removing meters on the Courthouse side of the Courthouse square. This area would be assigned to County-owned Sheriff's Department vehicles only. If this were done, it would alleviate our parking problem and the Courthouse Square could again be policed properly.
