Manager Shortt said May Construction Company had advised him that they had allowed for the more expensive method of paving this area with hard top, but if the City desired, they could replace the surfacing by a method called Penetration. This consists of a layer of crushed stone and a layer of asphalt. These materials compact to form a fairly stable roadbed. Manager Shortt said by using this method the City would save three or four thousand dollars. Manager Shortt said the City had the machinery to do this work and would be able to do it before cold weather. The Commission discussed the matter and Mayor Hambley said he felt that by using the Penetration method the City would incur more cost in the long run by having to re-surface more often. The Commission instructed the City Manager to advise Mays to go ahead and do the more expensive method as allowed in their contract.

City Attorney informed the Commission that he needed to file a condemnation suit on Drew Justice in order that the Cut Thru could proceed, but that Mr. Justice was a client and a relative to a member of his law firm. He asked that the Commission appoint a special attorney to handle this suit. Commissioner Robert Amos, Jr., made the motion to appoint Larry Webster to handle this condemnation suit. Commissioner W.
