Alexander concerning the contract between The City of Pikeville and my co.

I have enclosed a revised labor scale to be added to the contract for approval. As I told you in our meeting August 10, 1977 I would lower the labor rates all I could since the work in the old Pepsi Building is already in progress.

The estimated cost of completion of this project you ask for would be approximately thirty five thousand dollars.

The above estimated cost does not include the drive-in window (as it has not been determined as to what type of window service will be installed), Fire escape on back of building, rest rooms on first floor (as I understand it the second floor rest room will also serve the first floor.

The windows in the building are in very bad shape and should be replaced but I have only figured on repairing and painting them.

Outside of building to be painted and loose brick to be repaired.

The above estimated completion cost pertains to conservative measures only to complete this project.

There was a discussion concerning the wage scale.

Commissioner Roy E. Alexander stated that he had consulted with several contractors locally and one in Ashland concerning their standard wage scales. Commissioner Alexander stated that according to his comparisons, to enter into an agreement at the rates that were previously suggested by Chloe Plumbing and Heating, Inc. would set a precedent in this area that neither the City nor the contractors could live with and on that basis, he could not agree with the wage scale. Commissioner Alexander stated that he was in support of adequate office space but was not in agreement with several of the proposed renovations.

Mr. Ralph Justice, Chloe Plumbing and Heating, Inc. reported on the finished renovations and the repairs yet to be completed.

An agreement was presented between the City of Pikeville, and Chloe Plumbing and Heating, Inc. for renovations on the old Pepsi Cola Building for the city administrative offices.

No action was taken.

Commissioner Ratliff suggested that there be another meeting between city officials and the contractor to resolve any differences and to settle on a specific plan of renovation and approximate costs.

Mr. Ralph Justice of Chloe Plumbing and Heating, Inc., stated that the renovation work will be halted until the contract is established and payment is approved for work completed to date. Mr. Justice was in agreement with the Commission to resume the renovations upon approval of the contract and invoices, if the Commission so desired.

Commissioner Alexander suggested that the Commission delay any decision on a contract until consultation with the City Attorney, Lawrence Webster.

Invoices were submitted for approval by Chloe Plumbing and Heating, Inc. for work completed as of July 23, 1977 and August 5, 1977 in the amounts of \$14,071.79 and \$10,472.55 for renovations on the old Pepsi Cola Building.

The Commission was in general agreement that the invoices could not be approved for payment until the approval of a contract for the said renovations.

No action was taken.

Commissioner Roy Alexander requested that Mr. Bowen, City Manager prepare as much material as possible concerning the renovations for the meeting with the City Attorney in order that the matter may be settled quickly, with this provision Commissioner Alexander made the motion to adjourn the meeting. Commissioner Sid Ratliff seconded the motion.
