REGULAR MEETING - JANUARY 8, 1979

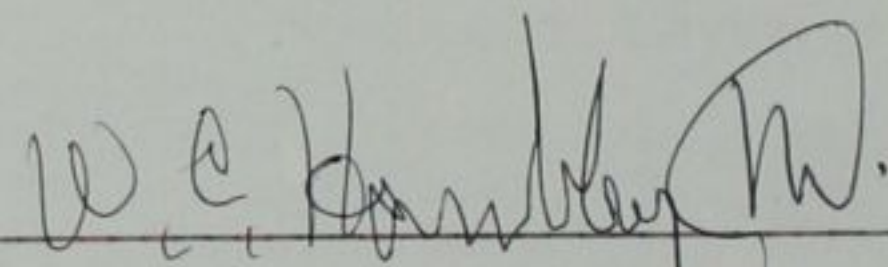
There were reports from the Fire Dept., Sewage Treatment Plant, and Traffic Violations. No Action Taken.
