RESOLUTION AUTHORIZING NETOTIATION OF LOAN IN THE PRINCIPAL SUM OF \$136,500.00 TO BE APPLIED TO THE WATER AND SEWER OPERATION AND MAINTENANCE FUND, AND GAS OPERATION AND MAINTENANCE FUND, AND TO BE PAID FROM WATER AND SEWER OPERATION AND MAINTENANCE FUND, GARBAGE FUND, AND GAS OPERATION AND MAINTENANCE FUND

WHEREAS, interim financing will be necessary in the sum of \$136,500.00 and the same will require the negotiation of a loan in the principal sum of \$136,500.00, for the application to the Sewer and Water Operation and Maintenance Fund, the Gas Operation and Maintenance Fund and the Garbage Fund, which money will be repaid \$18,500.00 from the Garbage Fund, \$51,000.00 from the Water and Sewer Operation and Maintenance Fund and \$67,000.00 from the Gas Operation and Maintenance Fund.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and City Clerk, are authorized to negotiate a loan at such an institution and upon such terms and conditions as they may deem advisable in the principal sum of \$136,500.00, to be repaid \$18,500.00 from the Garbage Fund, \$51,000.00 from the Water and Sewer Operation and Maintenance Fund and \$67,000.00 from the Gas Operation and Maintenance Fund by June 30, 1981.

BE IT FURTHER RESOLVED that the Mayor and City Clerk are authorized to execute such documents as may be necessary to secure the lending institution in the execution of the said Loan.

An emergency is declared to exist with regard to the foregoing Resolution and the same shall be in full force and effect immediately upon subscription and approval thereof.
