An Ordinance was brought before the Commission and given second reading. The Ordinance was read entitled:

An Ordinance was brought before the Commission and given second reading. The Ordinance was read entitled:

ORDINANCE RENAMING PETER FORK ROAD ~~0-84-003~~

Peter Fork Road will be renamed to Walters Road in honor of Dr. William J. Walters and his heirs.

Robert Page made the motion to adopt this Ordinance. Harding Dawahare seconded the motion. The motion carried unanimously.

Mr. Carlton reported that there are still two lots in Road Fork that have not been sold. The appraised value of these lots are \$32,050 and \$31,500.00. The Commission made no decision to put these lots out to bid.

A Resolution was brought before the Commission and was read entitled:

RESOLUTION REQUESTING THAT THE LEGISLATURE OF THE COMMONWEALTH OF KENTUCKY DECLARE PIKEVILLE TO BE A THIRD CLASS CITY ~~R-85-006~~

Frank Morris made the motion to adopt the Resolution. Rush Dye seconded the motion. The motion carried 4-1 with Robert Page voting no.

It was a unanimous decision of the Commission to allow the Police Chief, John Greer recruit for recommendation 3 Police Officers. One is to replace Patrolman Bill Scott and the other two are for Alcoholic Beverage Control and due to extra annexed territory.

Harding Dawahare made the motion to adjourn to a work session with Richard Reeher, architect for the Child Development Center Project. Robert Page seconded the motion. The Motion carried unanimously.
