REGULAR MEETING, APRIL 23, 1984

A Regular Meeting of the City of Pikeville Board of Commissioners was held on April 23, 1984 in the Regular Meeting Place of said Board in the Old City Hall Meeting Room on Division Street.

The meeting was called to order by Mayor Pro Tem, Harding Dawahare, at 7:30 p.m. Upon call of the roll, the following members were present:

Commissioner Frank Morris arrived later on in the meeting.

The minutes of Special Meetings of April 2 and 4, 1984 and regular meeting of April 9, 1984, were tabled until the next meeting.

In Business from the Floor, John Hall was present to complain that the three access roads to Julius Avenue have been made almost inaccessible due to London Bridge Company working on the Boulevard. The Commission will be in contact with David Barker, President of London Bridge to see if they can work out a solution to this problem.

Bill Moore of Pike Villa, Inc. was present to thank the Commission for attending the dedication of the Pike Villa Apartments and for cooperating with the contractors while the apartments were being built.

A request from the Pikeville Industrial Softball League to use the Upper Level of Poor Farm this year for Sunday afternoon games was heard by the Commission. Robert Page made the motion to allow use of the field for this purpose. Rush Dye seconded the motion. The motion carried unanimously.

There was no objection to the request to use the Upper Level of Poor Farm for T-Ball from May 19 thru the end of June.

City Bills in the amount of \$190,185.78 were presented to the Commission for approval of payment. Robert Page made the motion to approve payment. Rush Dye seconded the motion. The motion carried 3-0.

A bill from Wells Motors for the 2 new (1983) Police Cruisers in the amount of \$19,400.00 for approval of payment. This bill will be paid from the Revenue Sharing Account. Rush Dye made the motion to approve payment. Robert Page seconded the motion. The motion carried unanimously.

The motion was made by Rush Dye to adopt the Budget Amendment prepared cleaning up the extra funds (\$8,433.81) from the Community Development Agency. These funds are being transferred to the Child Development Center Fund. Robert Page seconded the motion. The motion carried unanimously. This action closed the Community Development Agency Fund. It is now ready for audit.

Community Development Bills in the amount of \$8,433.81 were presented to the Commission for approval of payment. Harding Dawahare seconded the motion. Upon call of the roll, the motion carried as follows:

Rush Dye made the motion to approve payment. Robert Page seconded the motion. The motion carried 3-0.

An Ordinance was brought before the Commission and given second reading. The Ordinance was read entitled:

AN ORDINANCE ESTABLISHING GRIEVANCE PROCEDURES RELATING TO SUSPECTED OR ALLEGED DISCRIMINATION OF THE BASIS OF HANDICAPPED STATUS IN THE CITY OF PIKEVILLE, KENTUCKY 0-84-021

Robert Page made the motion to adopt the Ordinance. Rush Dye seconded the motion. The motion carried unanimously.

The Commission was informed by Bill Moore of Pike Villa Apts. that 20% of the total contract work was given to local contractors.
