At 10:13 a.m., Mayor Combs made the motion, seconded by Commissioner Blankenship to adjourn to a closed session (pursuant to KRS 61.810 Section 3, paragraph (1) (f)) for the purpose of continuing with the disciplinary hearing concerning Police Officer, Johnny P. Meade, Jr.

At 12:13 p.m., Mayor Combs made the motion, seconded by Commissioner Davis to reconvene to regular session. Upon call of the roll, the motion carried 4 - 0.

At 12:14 p.m., Mayor Combs made the motion to recess the meeting until 1:15 p.m. Commissioner Blankenship seconded the motion. Upon call of the roll, the motion carried 4 - 0.

At 1:24 p.m., Mayor Combs made the motion to adjourn to executive session, pursuant to KRS 61.810 Section 3 paragraph (1) (f), for the purpose of continuing with the disciplinary hearing concerning Police Officer, Johnny P. Meade, Jr. Commissioner Blankenship seconded the motion. Upon call of the roll, the motion carried 4 - 0.

At 4:12 p.m., Mayor Combs made the motion to reconvene to regular session. Commissioner Blankenship seconded the motion. Upon call of the roll, the motion carried 4 - 0.

Mayor Combs stated that the Commission had been shown a statute which indicates that no officer of the City should make any public comment regarding the disciplinary action until finalized. He asked City Attorney Davis if they were to presume that the matter is finalized through all appeals or finalized with the City Commission's action. City Attorney Davis interpreted the statute to mean the City Commission's final disposition. The City Attorney cautioned the City Commission to not make any public comments concerning the matter outside of their official business.

Mayor Combs made the motion that the City Commission adopt a resolution finding Officer Johnny P. Meade, Jr. guilty of misconduct in violations of the Personnel Code of the City of Pikeville Police Department, specifically with reference to Code Numbers 3.1 Rule #15; 3.1 Rule #37; 3.5 Rule #20; 3.5 Rule #38; and 3.5 Rule #49; and that the resolution contain a discipline of an official reprimand for misconduct in violation of the aforementioned code numbers along with a suspension without pay for three months to become effective aforemediately. Commissioner Blankenship seconded the motion. Upon call of the roll, the motion carried 4 - 0.

There being no further business to come before the Commission, Mayor Combs made the motion, seconded by Commissioner Blankenship to adjourn the meeting. Upon call of the roll, the motion carried 4 - 0. (Adjournment Time: 4:18 p.m.)
