## CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES August 27, 2018 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, August 27, 2018. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Commission Members present at roll call were as follows:

### **MINUTES**

The minutes for the previous regular meeting held on August 13, 2018 were in each Commission Member's agenda package. There being no additions or corrections, Commissioner Hartsock made the motion to approve the minutes as prepared. Commissioner McNamee seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 5-0.

### PAYMENT OF CITY BILLS

The City Manager Philip Elswick requested the approval to pay city bills in the amount of \$1,637,703.56. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0.

#### CITY ENGINEER

Brad Slone was present and submitted several requests to the commission for approval.

- 1. Consider request to approve and authorize payment of Integrated Engineering Invoice No. 3985, as submitted, for \$20,460.00 for the Bob Amos Events Center and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 2. Consider a request to authorize and approve payment of Integrated Engineering Invoice No. 3979, as submitted, for \$11,425.50 for the Julius Avenue Slide Stabilization Project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 3. Consider a request to authorize and approve payment of Judy Construction Company Pay Request No. 11, as submitted, for \$622,493.75 for the Wastewater Treatment Plant Upgrade Project and grant the City Manager or Deputy City Manager of Operations/City Engineer authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 4. Consider a request to authorize and approve payment of Vaughn & Melton Consulting Engineers, Inc. Invoice No. 47, as submitted, for \$30,429.19 for inspection for the Wastewater Treatment Plant Upgrade Project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments. Mr. Slone says that everything is where it should be and there have been weather days added with opportunities to catch up. Mr. Elswick added that it is essentially fifty percent done. Mayor called for additional comments, there being none, the motion passed unanimously. 5-0.
- 5. Consider a request to authorize and approve payment of Overhead Door Company of Eastern KY Invoice No. 4826, as submitted, for \$27,500.00 for the Bob Amos soccer field fencing project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Hartsock made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 6. Consider a request to authorize and approve payment of Tackett Builders Invoice No. 2, as submitted, for \$8,702.50 for the Hambley Athletic Complex Training Center Roof Repair Project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner

Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.

### CITY ATTORNEY

Russell Davis was present and had the following items to read into record.

1. Consider a second reading of Ordinance No. 0-2018-16, as submitted, amending Chapter 111.31 – Microbreweries and grant the Mayor the authority to sign and execute said ordinance on behalf of the City of Pikeville. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, Mayor called roll call.

Consider a second reading of Ordinance No. 0-2018-17, as submitted, amending Chapter 36.73 – Model Procurement and grant the Mayor the authority to sign and execute said ordinance on behalf of the City of Pikeville. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, Mayor called roll call.

Ordinance passed.

3. Consider a first reading of Ordinance No. 0-2019-19, as submitted, creating and establishing for bid a non-exclusive electric franchise. Second reading and passage of this ordinance will take place at next scheduled meeting.

## **CITY MANAGER**

City Manager Philip Elswick presented the commission with the following items for approval:

- 1. Consider a request to adopt a proclamation honoring Sandy Runyon for her service to the region as Executive Director of the Big Sandy Area Development District and grant the Mayor the authority to sign and execute said proclamation on behalf of the City of Pikeville. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments and thanked Mrs. Runyon for all the projects over the years and all the help that she has provided to the city. Each commissioner also thanked Mrs. Runyon for the opportunities she has provided to the community. Mayor called for additional comments, there being none, motion passed unanimously. 5-0.
- 2. Consider a request to authorize and approve a Service Agreement/Renewal Invoice No. GMA-5811, as submitted, for \$772.86 for maintenance of the Utilities Department copier and grant the Mayor the authority to sign and execute any and all necessary documents. All invoices will be paid with grant funds. Commissioner Hartsock made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, and Mr. Elswick noted that the language regarding the use of grant funds was inaccurate. Mayor Carter called for additional comments, there being none, the motion passed unanimously. 5-0.
- 3. Consider a request to amend Section 1.10 Education Assistance and Career Education and Section 4.18 Vehicle Use of the City of Pikeville Personnel & Operating Policy Guidelines. Commissioner Hartsock made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments. Commissioner May-Downey suggests that for the education assistance that the requirement be changed as must get standard minimum grade instead of B standard. She also suggests for first responders, that they shouldn't have to seek reimbursement. Mr. Elswick responded that the first responders do not apply in this matter. Commissioner May-Downey was also concerned about the vehicle use policy pertaining to alcohol being within reach. She wanted to make sure it was within regulations. Mayor says we can approve this item based on changes, he then calls for additional comments, there being none, the motion passed unanimously. 5-0.
- 4. Consider a request to authorize and approve the advertisement of a Request for Proposals for the purchase and delivery of carbonated beverages for City owned facilities. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 5. Consider a request to authorize and approve the advertisement for bids for Street Striping for 2018. Commissioner Hartsock made the motion to approve.

- Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 6. Consider a request to set Trick-or-Treat in the City of Pikeville for October 30, 2018 from the hours of 6 p.m. to 8 p.m. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 7. Consider a request to re-appoint Jody Hunt to the Board of Zoning Adjustments for a term ending on May 1, 2022, Mark White, Mark Batten and Tim Malone to the Technical Advisory Committee for terms ending on February 27, 2022, and Reed Potter to the Hatfield & McCoy Pikeville/Pike County Museum Board for a term ending on April 1, 2022. Commissioner May-Downey made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 8. Consider a request to authorize and approve the purchase of 100 licenses of Power DMS, as outlined in the submitted quote, and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments and Mr. Elswick explains that this is a web base software package for HR to post trainings and policies. Mayor called for additional comments, there being none, the motion passed unanimously. 5-0.
- 9. Consider a request to authorize and approve submittal of a Pretreatment Plan to the Kentucky Division of Water, as submitted, upon completion of review and modification of the plan by the City Manager and City Attorney and grant the City Manager authority to sign and execute any and all necessary documents. Commissioner May-Downey made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 10. Consider a request to authorize a conditional offer of employment to Mollie McGuire, Shaua Brown, and Shelby Handshoe for the position of Dispatcher based upon successful completion of all required testing. Commissioner Hartsock made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 11. Pursuant to KRS 61.810, consider request for closed session for discussion of economic development, legal and personnel issues. Commissioner McNamee made the motion. Commissioner May-Downey seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0.
- 12. Commissioner McNamee made the motion to reconvene. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0. Mayor called the session back into order.

- 13. Consider a request to authorize and approve a Development & Guaranty Agreement with EnerBlu and grant the Mayor the authority to sign and execute said agreement upon completion of negotiations by the City Manager and City Attorney. Commissioner McNamee made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 14. There being no further business to come before the Commission, Commissioner McNamee has made the motion to adjourn the meeting. Commissioner May-Downey seconded the motion. Mayor Carter called for discussion, there being none, the meeting was adjourned. 5-0.
